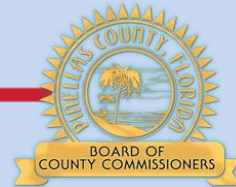


- Land Development Code “QUICK FIX” results

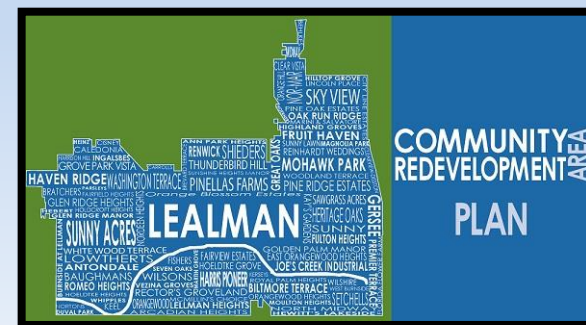
- RESTORE Act Grant (\$300,000 Award)

- Countywide CRA Policy Guidelines

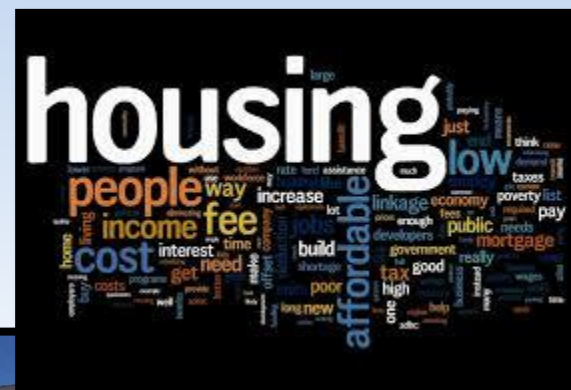

≤ 49	Economic Development	10 years	5 years	Up to 50%

 - 13 original tenants

 - City and agency Partners



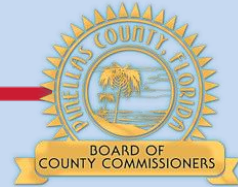
