Hi Ken & Gina,

The above item is currently in my queue for review. I have several questions about this agreement. In section 3 on page 3 (Billing and Payment), it reads as though there will only be a one-time reimbursement for the design, enforcement of material & installation standards, purchase and establishment of plants (not to exceed \$1.0M), only *after* a 90 day establishment period and approval of the installation by FDOT. The time frame given for completion of the project is two years.

- Is the County is expected to front 100% of these funds to do this project and not be reimbursed for it until 2 years and 3 months after project completion and approval by FDOT? The intent is that the County would front the money and get reimbursement through the grant. As I read it we have a maximum of 2 years to complete the project and 90 days after the establishment of the landscaping to start closing out the project. We don't anticipate the project to take more than one year to complete.
- Who will be responsible for ensuring the project is completed within two years? The County will do the project so we can make sure the project stays on schedule. We will do design and contract out the work.
- Do we have any estimates or is there assurance that this project can be completed for no more than \$1.0M?
   The extent of the landscaping will be controlled to make sure the cost stays within the \$1 million funding limit.

The agreement states that the County is responsible for all maintenance for 10 years (with automatic renewals), but no mention of reimbursement of costs for maintenance.

• Who will be paying for and overseeing the maintenance? The County will provide project management and inspection for the project but will be reimbursed from the grant funds when complete.

In Section 2c. (Installation), it states that the County will be responsible for providing a Certified Worksite Traffic Supervisor at the site of construction or maintenance.

 Who is responsible for paying for and overseeing this person? The County will provide project management and contract inspection for the project but will be reimbursed from the grant funds when complete
