The purpose of the request for applications is to provide funding under the Program to counties. However, a not-for-profit community provider may apply. Operation PAR proposes to implement the Marchman program in the jail. To do this, the Sheriff has to support the program and he is a member of the Public Safety Coordinating Council and approved this proposal. (The money has to be used to improved public safety initiatives within counties and it requires BCC approval.)

I am the coordinator of the Public Safety Coordinating Council and is facilitating the requirements of this grant. However, the county is not required to contract with Operation PAR and will not be

receiving any funding. If awarded, Operation PAR is required to report quarterly to the Public Safety Coordinating Council. (The final grant report has to be approved by the Board.)

Per our telephone conversation, the intent of Legistar Item 17-752A is to receive Board approval of the recommendation from the Public Safety Coordinating Council for Operation PAR to apply for the Criminal Justice, Mental Health, and Substance Abuse (CJMHSA) Reinvestment Grant. The Request For Proposals for this Department of Children and Families grant requires a recommendation from the Board. There is no formal letter required from the Board.

Commissioner Gerard is Chair of the Public Safety Coordinating Council, which met on April 27, 2017 and selected Operation PAR to apply for this grant.
