#### PRESENTATIONS AND AWARDS

Noting that Pinellas County was included in the seven out of 67 counties receiving the prestigious awards, Chairman Long and Mr. Woodard presented them to the following Pinellas County employees:

- Nancy McKibben, Ivanetta Dorsey, David Brown, and Stephen Robinson (Curlew Creek Channel A)
- Dennis Grizzell and Eric Fehrmann (Public Works Stormwater Operations)
- Lyle Fowler and Ivanetta Dorsey for (Fort De Soto Bridge)

Ms. McKibben indicated that Curlew Creek Channel A was an ambitious flood control and creek stabilization project, in the course of which the creek and its habitat were restored, and Ms. Dorsey related that the Fort De Soto Bridge project helped address silt buildup, improve the flow of the water, and clean up a portion of the bay. Mr. Woodard pointed out that the projects were funded by the Penny for Pinellas tax; whereupon, a video displaying the projects was presented.

Later in the meeting, Chairman Long recognized Public Works Department employees Joseph Boggs, Josephine Benwell, and William Logan for receiving the American Public Works Association Scholarship Awards.

Chairman Long remarked on the highly skilled EMS Department professionals and introduced a video showing their stories and accomplishments; whereupon, Pinellas Federal Credit Union Vice President of Administration Gina Signor presented Messrs. Sherman, Sims, and Nolan with monetary awards.

Thereupon, Chairman Long informed the audience that the Commissioners are wearing blue ribbons today in honor of National Police Week which begins May 14.

Dr. Weiland referred to a PowerPoint presentation titled Doing Things! Partner Presentation: Pinellas County EMS Advisory Council EMS System Update, which has been made a part of the record, and discussed the Council's membership, mission, and goals; status of the EMS system, including improvements and challenges; ambulance transport trends; and increased service demand and its evaluation by the Council; whereupon, he responded to queries by the members.

#### COUNTYWIDE PLANNING AUTHORITY

5. Case No. CW 17-2 - City of Pinellas Park

Countywide Plan Map Amendment from Retail & Services and Target Employment Center to Employment and Target Employment Center, regarding 1.9 acres more or less, located at 11425 66th Street North (regular amendment).

Ordinance No. 17-13 adopted. Forward Pinellas, in its role as the Pinellas Planning Council, recommended approval of the proposal, and staff concurred. No correspondence has been received. No citizens appeared to be heard.

Forward Pinellas Program Planner Alicia Parinello referred to aerial and street-level photographs and the land use map, pointed out the subject parcel, described surrounding land uses, and provided an overview of the proposal, indicating that the purpose of the amendment is to accommodate the granite fabrication and manufacturing proposed for the site; whereupon, she stated that staff has found the proposal

consistent with the Countywide Rules and recommends approval.

Case No. CW 91-13 (SAP Change No. 5-2017) City of Pinellas Park Countywide Plan Map amendment of an existing Activity Center (governed by the Pinellas Park Community Redevelopment Plan) for a 1.7 acres more or less parcel located at 7651 U.S. Highway 19, increasing the permitted density from 12.5 to 24 units per acre, decreasing the permitted floor area ratio from 0.65 to 0.55, and changing permitted uses to allow for predominantly commercial uses (regular amendment).

Ordinance No. 17-14 adopted. Forward Pinellas, in its role as the Pinellas Planning Council, recommended approval of the proposal, and staff concurred. No correspondence has been received. No citizens appeared to be heard.

Referring to aerial and street-level photographs and the land use map, Forward Pinellas Program Planner Alicia Parinello pointed out the location of the subject area, described surrounding land uses, and provided a brief overview of the proposal. She indicated that the Crown Honda automobile dealership, located on the adjacent property to the north, plans to expand its area to the subject parcel; that the existing Activity Center category will remain the same with regard to the Countywide Plan Map; and that the proposed amendment would change the density and intensity.

Ms. Parinello stated that staff has found the proposal consistent with the Countywide Rules and recommends approval; whereupon, responding to queries by Commissioner Justice, she provided clarification regarding the changes occurring under the amendment.

## **BOARD OF COUNTY COMMISSIONERS**

7. Petition of A.D. Morris Properties, Inc. to vacate portions of Haines Road North and 34th Street rights-of-way adjacent to 6901 U.S. Highway 19 North, Pinellas Farms, in Section 34/30/16, Pinellas County, Florida (legislative hearing).

Resolution No. 17-27 adopted granting the petition with regard to the 34th Street North right-of-way only. Authority granted for the Clerk to record the resolution. Letters of no objection have been received from all appropriate parties. Interested property owners were notified as to the date of the public hearing. Staff had no objection to vacation of the 34th Street North right-of-way and recommended that vacation of the Haines Road North right-of-way be denied. No correspondence has been received.

Referring to a PowerPoint presentation which has been made a part of the record, Real Estate Management Director Andrew Pupke indicated that the hearing was properly advertised and provided historical background information regarding the petition. Responding to queries by Mr. Woodard and Commissioner Welch, he confirmed that the petitioners' property is located between the two right-of-ways; whereupon, he identified them on the map and provided a detailed explanation of staff's position concerning their use and vacation, noting that two separate resolutions have been created for the Board's consideration.

Florida Department of Transportation (FDOT) Assistant General Counsel Rodney Wade and Project Manager Lillian Escalera referred to a map and an aerial photograph of the section of U.S. Highway 19 located near the petitioners' property and the subject right-of-ways and discussed the ongoing Project Development and Environmental Study to improve safety and accommodate various traffic types on U.S. Highway 19, including auxiliary and buffer bike lanes, pedestrian refuge in the median, and enhancement of sidewalks. Indicating that the Haines Road right-of-way portion will be utilized for improvements, they requested that the members deny its vacation, and discussion ensued.

Commissioner Morroni observed that FDOT has been planning to improve the area since 2013 and inquired about the project timeline; whereupon, Ms. Escalera indicated that the design phase is scheduled for Fiscal Year 2019; and that the main focus of the improvements is for the intersection of Gandy Boulevard and U.S. Highway 19. Commissioner Seel pointed out that problems in the area were recognized and prioritized by the Metropolitan Planning Organization when she chaired it, and the FDOT representatives and Mr. Pupke confirmed that the project is dependent on the Haines Road right-of-way; however, there are no objections to vacating the 34th Street right-of-way portion.

During discussion concerning ownership of the Haines Road right-of-way, Mr. Pupke noted that subsequent to the State's transfer to the County, the County issued a utilization permit to Pinellas Park, which entered into a landscape and maintenance agreement with the petitioners. Chief Assistant County Attorney Jewel White explained that vacating the right-of-way would be releasing it without making a determination as to the ownership, which may then be decided by a court of law and would likely be divided between the County and the petitioners.

In response to the Chairman's call for persons wishing to be heard, Attorney Matt Weidner, St. Petersburg, appeared and stated that he represents the petitioners. He provided background information regarding the petition, and referring to photographs of the Haines Road right-of-way, related that it is blighted and abandoned, and will get worse if not vacated. He noted that the FDOT letter dated February 24, 2017, which was made part of the record, and the meetings with FDOT representatives have indicated to the petitioners that, up until yesterday, FDOT did not object to the vacation; and that the U.S. Highway 19 improvement project is not definite.

Responding to queries by the members, Mr. Weidner discussed the petitioners' difficulties in maintaining the right-of-way and the need to have access to U.S. Highway 19 from their property. He stressed that they are seeking any positive alternative to status quo, such as a transient or conditional use enabling utilization of the right-of-way for parking; whereupon, Attorney White indicated that if the right-of-way is not vacated, it would remain public; therefore, any potential conditional use should be nominal. Mr. Pupke noted that the County does not normally allow right-of-way utilization permits for permanent structures.

In response to queries by the members, Mr. Wade indicated that he is not familiar with the aforementioned letter of no objection; that FDOT plans to proceed with the project, contingent on the outcome of the public hearings; and that while it will be determined through FDOT's access management program, access to U.S. Highway 19 is possible, based on the circumstances.

In rebuttal, Mr. Weidner expressed concern that the meeting agenda packet did not include pertinent documentation; and that he had no opportunity to fully investigate FDOT's new position with regard to the Haines Road right-of-way and the upcoming project facts presented today; whereupon, Commissioner Welch requested information relating to the documentation, and Mr. Pupke indicated that information regarding the FDOT project was relayed to the petitioners during a meeting in April.

In response to the Chairman's call for persons wishing to be heard, the petitioners, Donald and Alice Morris, St. Petersburg, appeared, stated their concerns, and provided letters in support of the petition, which have been made part of the record. They described the dire condition of the Haines Road right-of-way due to the County's abandonment and their efforts to clean it at a cost of \$30,000, noting that they won an award for their property improvements; whereupon, the following individuals spoke in support of the petition:

Thereupon, the members discussed partial vacation of the Haines Road right-of-way, the need for the petitioners' and other nearby properties to have access to U.S. Highway 19, and balancing the County's long-term infrastructure needs with support for the petitioners' request. Commissioner Eggers expressed concerns regarding neglect of the County property; whereupon, Messrs. Woodard and Pupke pointed out that notwithstanding the property's condition upon transfer from the State, it has been maintained according to the County's level of service; that issues of inadequate water or electricity supply to the site should be addressed by Pinellas Park, as the County is not party to the maintenance agreement; and that the matter at hand concerns ownership of land for the public benefit.

A motion was made by Commissioner Morroni, seconded by Vice-Chairman Welch, that the resolution granting the petition to vacate be approved with regard to the 34th Street North right-of-way only. The motion carried by the following vote:

Assistant County Administrator John Bennett, with input by Managing Assistant County Attorney Don Crowell, provided information regarding the current open burn prohibition ordinance and a separate ordinance pertaining to local parks and preserves; whereupon, he discussed administrative capabilities, emergency management powers, and public service announcements, and Mr. Woodard provided input.

In response to comments and queries by the citizens, Mr. Woodard provided historical background information regarding the Seminole Water Tower, including the age and ownership of the structure, maintenance and operating costs, decommission date, and plans for demolition; whereupon, he reported that he has had numerous conversations with the City of Seminole; that favorable terms were presented for purchase/lease of the land and tower; that the City Council was provided an engineering report and advised of upkeep costs; and that while Pinellas County has delayed demolition efforts, the Council continues to vote against acquisition of the property.

In response to comments and queries by the members, Mr. Woodard discussed property acquisition costs, deferred maintenance costs, appraised values, liability and safety issues, correspondence and meetings, and reluctance by Seminole to purchase the parcel. Commissioner Gerard requested that Seminole be approached one more time and presented an option to lease the land, and Commissioners Seel and Eggers agreed; whereupon, Chairman Long and Commissioner Morroni questioned why Seminole did not apply for BP Oil Spill Funds or utilize Penny for Pinellas dollars, indicating that even though several people have spoken today in favor of saving the tower, many residents are opposed to the idea; and that Pinellas County cannot frivolously donate assets, and Commissioner Welch provided input.

In response to query by Chairman Long, Mr. Woodard confirmed that he will contact the City Manager, ensure that a lease option is presented, and report back to the members at a future date.

· American Manufacturing Skills Initiative: Discussed her conversation with
