## ORDINANCE 2017-15

AN ORDINANCE OF THE CITY OF TARPON SPRINGS, FLORIDA, AMENDING ORDINANCE 2016-11; CORRECTING THE LEGAL DESCRIPTION FOR THE ANNEXING OF 0.96 ACRES, MORE OR LESS, OF REAL PROPERTY LOCATED AT 1525 RAINVILLE ROAD LYING IN THE SOUTH HALF OF SECTION 1, TOWNSHIP 27 SOUTH, RANGE 15 EAST; PROVIDING FOR FINDINGS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners of the City of Tarpon Springs adopted Ordinance No. 2016-11 on October 18, 2016 annexing .96 acres of real property located at 1525 Rainville Road; and

WHEREAS, the City of Tarpon Springs recently became aware of an error in the legal description of Section 2: Annexation, Attachment A; and

WHEREAS, the Board of Commissioners of the City of Tarpon Springs desires to correct this error; and

WHEREAS, the passage of this ordinance complies with all other laws and regulations of the State of Florida.

WHEREAS, the Planning and Zoning Board conducted a public hearing on this Ordinance on April 17, 2017; and

WHEREAS, published legal notice of this Ordinance has been provided pursuant to the requirements of Chapter 166.041, F.S. and Section 206 of the Tarpon Springs Comprehensive Zoning and Land Development Code.

## NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF TARPON SPRINGS, FLORIDA:

Section 1. Ordinance 2016-11, Section 2, Annexation, Attachment A, shall be hereinafter amended to read as follows:


