Tom McKone feels that PHCSA itself should look at the preliminary budgets to see where they are going and it's the Board's fiduciary responsibility to look at the budget. Barbara Cole wondered when the Homestead tax cut would go into effect and Erica and Tom responded that this would occur in 2019.

Old Business: Changes to fines for Library

Update and thank the Board for the letter to PPLC Board regarding the DVD fines. The latest recommendation is for a

25 cent fine across the board, DVD's, books etc. This is still up in the air until the different city governments discuss

and then approve this.

New Business: Revised BP Funding Agreement

Rex and Paul Sacco met with the group last month regarding the bid for the ELCL expansion building that came in

higher than budgeted and between Pinellas County staff and Pinellas County School staff the communication for the

shared parking was not getting where we wanted and there was confusion. This led to seeing if some BP funds for the

parking could be transferred to the building fund to make up for some of the costs and leaving less for the parking fund.

Paul Sacco spoke with Mark Woodard and Rex talked with Commissioner Eggers and they both seemed positive about the

potential.

If this change is approved by the PHCSA Board tonight, it will go on the County Commission Agenda in July. If this is

agreed upon by the County, \$200,000 will move to the expansion building project and \$150,000 will remain in the parking

project.

MOTION: Made by Tom McKone and seconded by Rob Posavec to accept the new BP funding agreement that will

move \$200,000 of the parking project money to the ELCL expansion project, leaving \$150,000 in the parking project.

Rob Posavec asked where was the original parking, the \$350,000 parking? Lois explained the conceptual plan was

to have some of the parking in front of the library and then to extend to the back of the Cypress Woods Elementary

School property. Rob wanted to know what was going to be the benefit to them and Lois said that parents use the

library parking lot to walk their children over to the school. This helps with the safety issue.

Barbara Cole asked if there was a contract and Erica shared that it ended April 30.

Andrew said that paying for the sod is a past practice but not in writing. Therefore, we have nothing to sue.

Erica feels using CSA monies would be a misuse of budgetary dollars since WFF owes CSA money and are currently using another PHCSA entity field. Tom McKone asked Mark Sanders if he had anything in his contract with WFF regarding sod replacement. Rob Posavec replied that they handle it differently, it's a different contract. Rob proceeded to explain what WFF does handle at the ELR fields. Much discussion continued.

Andrew Salzman and Erica will speak about drafting a letter to West Florida Flames from CSA.
