## **REASON FOR CHANGE:**

This change order adds two (2) items to the intersection improvement project on 102<sup>nd</sup> Avenue at 113<sup>th</sup> St/118th St/119th St. Additions include milling and resurfacing from east of the Pinellas Trail to 113th Street, and sidewalk construction along the south side of 102<sup>nd</sup> Avenue from Windtree Boulevard to 119<sup>th</sup> Way.

The engineer's estimate for the milling and resurfacing, using the bid unit prices, is \$158,615.20. This includes one (1) additional item not currently in the contract - 710-11-160 Painted Payement Marking, STD, WHITE, MESSAGE. The item will be added to the contract as part of this change order.

The cost for the proposed sidewalk construction is \$85,137.50. There is currently a sidewalk gap of approximately 1,270 linear feet from Windtree Boulevard to 119th Way within the limits of the proposed intersection improvements. Construction of the sidewalk will provide a completed network along the south side of 102<sup>nd</sup> Avenue from Hamlin Boulevard to Ridgeview Lane – a total of 2.38 miles.

Total cost for the additions is \$243,752.70.

The contractor agrees to conform to all existing contract specifications as well as those specific to this work.

There is no time extension associated with this change order.
