FIRST AMENDMENT

This Amendment made and entered into this _____ day of _____, 20__, by and between PINELLAS COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "County," and CITIZENS RX, LLC, Oak Park, IL 60301, hereinafter referred to as "Contractor," (individually "Party," collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on September 10, 2015, pursuant to Pinellas County Contract No. 145-0204-B(JA) (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Pinellas County Indigent Health Program pharmacy services for County; and WHEREAS, Section twenty-one (21) of the Agreement permits modification by mutual written agreement of the Parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement, at the same prices, terms, and conditions;

NOW THEREFORE, the parties agree that the Agreement is amended as follows:

- 1. Replace first sentence of Section 5 Compensation and Method of Payment, paragraph B. Compensation, to read: "The County agrees to pay the Contractor the annual not-to-exceed sum of \$5,480,000.00, except for year 2 of the contract where the annual not-to-exceed sum will be \$6,030,000.00. The total contract (sixty month) not-to-exceed sum will be \$27,950,000.00 for services completed and accepted as provided in this Agreement, payable according to the terms of Exhibit C and pursuant to all other terms of the Agreement."
- 2. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
