If you want to charge someone not living in Pinellas County a fee, then that is one thing, but to charge residents that can prove they live here to pay \$5 a day is insane.

The Canadian Blue Jays are not a major team that brings in enough people to pay dribble for what we have been charged in the past. No more. We are done with this. If the people of Dunedin want to vote to spend money, then that is fine. Let them make that decision, but ONLY if they want to do that.

We Pinellas county residents know the wind is blowing; that this is not the way to spend our money, any more than a high-speed rail..which is a joke... The rail from NO WHERE to NO WHERE at a cost in the BILLIONS which would bankrupt Pinellas and other counties. People would have to drive their cars somewhere to get on and then off and where would they go??
