A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA DECLARING FIVE ESCHEATED PROPERTIES SURPLUS, AND AUTHORIZING CONVEYANCE OF TWO PROPERTIES TO THE CITY OF CLEARWATER AND THREE PROPERTIES TO THE CITY OF ST. PETERSBURG.

WHEREAS, the following properties in the municipal boundary of the City of Clearwater described as: Palm Park, the South 50ft of West 100ft of Lot 32, also known as Parcel Number: 10/29/15/65718/000/0321, and Drew Park, Lot 8 also known as Parcel Number: 10/29/15/22518/000/0080, escheated to the County in accordance with Florida Statute §197.502 (8); and

WHEREAS, the following properties in the municipal boundary of the City of St. Petersburg described as: Palmetto Park, Block 2, the South 34ft of Lot 1 also known as Parcel Number: 23/31/16/65862/002/0011, and Croxton Sub Block 1, Lot 12, also known as Parcel Number: 30/31/17/19782/001/0120, and Kerr Add, Block 3, Lot 3 also known as Parcel Number: 30/31/17/46404/003/0030, escheated to the County in accordance with Florida Statute §197.502 (8); and

WHEREAS, Florida Statute §197.592 (3) requires the County to convey such parcels to the respective municipalities in which the parcels are located if the Board of County Commissioners does not acquire the Property for infill development, does not dedicate the parcels as needed for County purposes, or does not convey the Property to the previous record fee simple owner; and

WHEREAS, County staff has determined that the properties referenced above are not needed for infill or other County purposes, and restitution of the Properties to the previous record owners is either not feasible or desired.
