- 12,250 students impacted





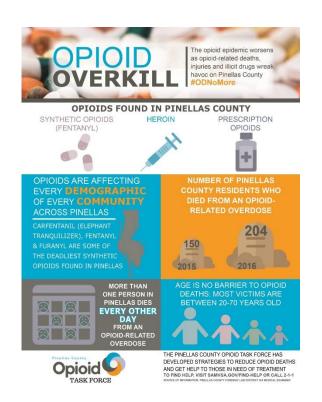

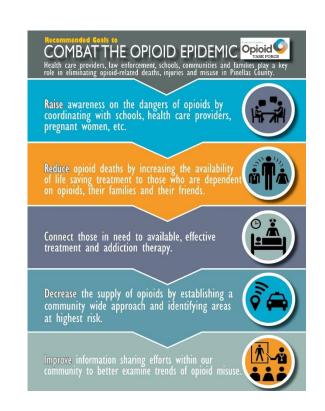
- Two dental sealant teams

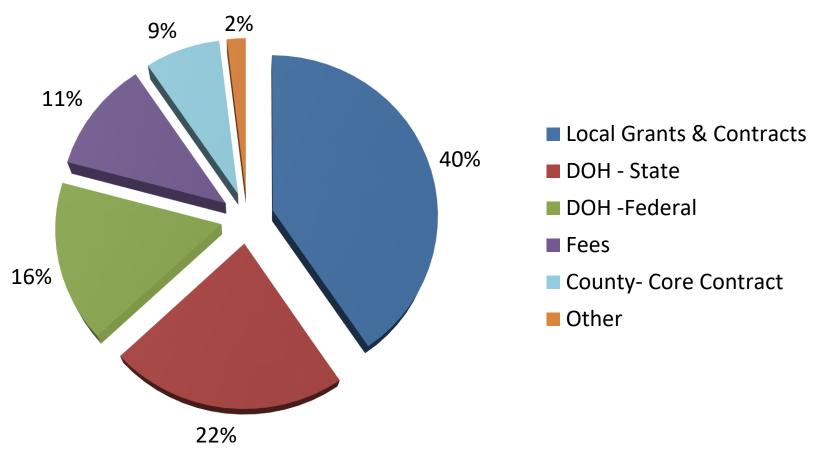
#### Health in All Policies

- Acknowledges that social determinants of health have a profound impact on health



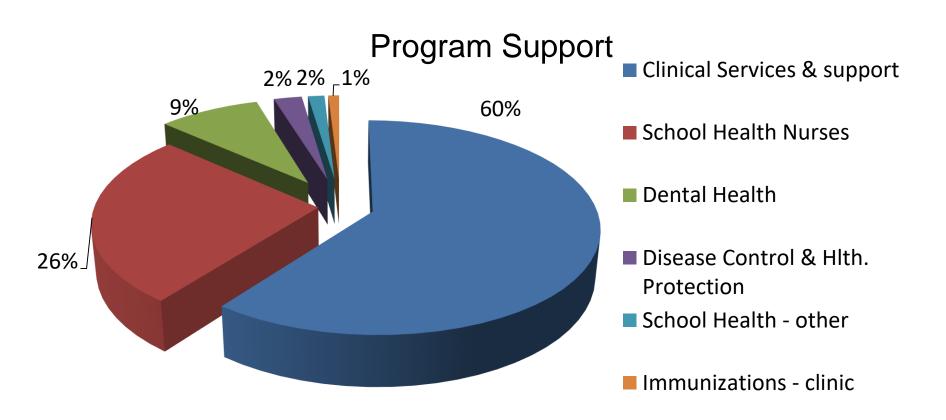
## FY 2017 - 2018 Financial Resources \$55,377,262

# Performance Measures FY 2018-2019



- HIV Infections: Reduce the annual number of newly diagnosed HIV infections in Pinellas from 278 (2014) to 261 overall and from 77 to 72 in the black population by Dec. 31, 2018.
- Childhood vaccines: Increase percent of those eligible for HPV vaccine and reported through FL Shots who have completed the 1<sup>st</sup> HPV shot from 6.5% (2014) to 7.96% by Dec. 31, 2018.
- Increase the number of children served by the Pinellas County school-based sealant program from 4,000 (2016) to 5,500 by Dec. 31, 2018.
- Increase the percentage of children who are at a healthy weight from 60% (2014-2015) to 63% by Dec. 31, 2018.

# Proposed changes to User Fee Schedule FY 2018-2019



- 1. Change description for certification issuance for include all foreign travel vaccines.
- 2. Eliminate the Dental services for children under 19 years fee, so as to standardize the fees for both Adult & children and, to allow sliding fee scale to apply.
