

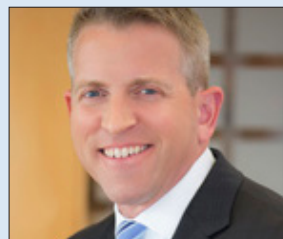

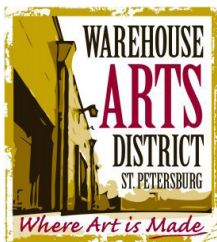


Madeira Beach

As the lobbyist for the city of Madeira Beach we led the development of an appropriations strategy resulting in the legislature funding \$145,000 of the city's needed storm water improvement plan in the 2015 session. Suskey Consulting is the only lobbyist the city has ever had and is also responsible for a number of ongoing water and transportation projects at the city.

The entertainment district of John's Pass is located within Madeira Beach. The city has maintained lighting in and around the crosswalks in recent years but as tourism numbers have grown so has the need for additional traffic safety lighting. Suskey consulting worked with the legislature and FDOT to obtain \$350,000 for an innovative lighting system in and around the pedestrian areas of the facility.

During the 2017 session we worked with Sen Jeff Brandes and House leadership to assist the city in improving their fast-growing softball field complex, a major economic development driver for the city. After reviewing the city's plans, we were able to secure \$200,000 for a new lighting concept at the NCAA softball fields.



St. Petersburg Warehouse Arts District

The Arts community in St Petersburg has long been a major attraction and economic driver. In the 2016 session, we led the effort to secure \$300,000 in funding from the legislature to establish the Warehouse Arts District in St Petersburg. Following that, we were able to secure \$400,000 in the 2017 session. This funding will serve to create much needed studio space for local artists at an affordable cost.



Pinellas Suncoast Transit Authority (PSTA)

During the 2015 budget session PSTA requested a \$1,000,000 appropriation to assist in the establishment of the Central Avenue BRT line. This funding was the #1 priority of the authority during the session and would connect downtown St Petersburg to the beaches. Suskey Consulting was hired as a subcontractor during the session to assist in convincing the local delegation and legislative leaders of the need for this project.

Qualifications

After much discussion with the Department of Transportation, PSTA staff, and legislative leaders, Mr. Suskey developed a strategy for FDOT to fund the request internally, thereby avoiding any conflict with the Governor's Office. FDOT has since funded the project and the establishment of the BRT line is underway.

During the 2017 session, we were successful in securing \$1,000,000 for the authority to begin the planning and development of a long-planned Clearwater transportation project.



PSTA Transportation Disadvantaged Funding

The legislative formula used to establish transportation disadvantaged funding in the state of Florida is in dire need of updating. The current formula place emphasis on rural counties at the expense of urban counties such as Pinellas. Realizing this, the PSTA board added the issue to the 2016 legislative priority list. Suskey Consulting led the effort with PSTA to request that the legislature study the issue in Florida and compare our system with other states around the country. The legislature agreed and provided \$200,000 to the department of transportation to study the issue and provide findings prior to the 2017 session.



Monroe County

As a member of the team representing Monroe County, Mr. Suskey assisted the county in securing \$50,000,000 to upgrade their severely inadequate aqueduct system.



Tampa Bay Innovation Center on behalf of Pinellas County

The Tampa Bay Innovation Center is a not-for-profit entity funded by the Pinellas County government. They serve as a technology incubator for clients and surrounding areas, promoting technology companies and assisting them in their growth and business planning. Commissioners and staff to draft a fare ordinance for all investors. RSA also helped ABC put on Build Tampa Bay. An event targeting juniors and seniors in Hillsborough, Pasco, and Pinellas County schools to help them learn about the construction industry and the exciting careers in the field. Over 600 students attended this event with over 50 construction vendors from around the bay area. This event made statewide attention as it was hosted at Amalie Arena.

BACKGROUND

McKechnie Field, opened in 1923 and rebuilt in 1993, is one of the oldest ballparks used for Spring Training. Located in Bradenton, six different major league franchises, including the St. Louis Cardinals and Boston Red Sox, have played home games at McKechnie Field since its opening, but only the Pittsburgh Pirates have called the ballpark home since 1969.

SUPPORT PROVIDED BY RSA

The Pittsburgh Pirates' Spring Training ballpark and minor league complex has undergone extensive renovations since 2008 as part of the team's 30-year lease with the city. These renovations totaled \$20 million. About \$9 million was covered by a state-funded program designed to keep teams that currently hold Spring Training in Florida from leaving for Arizona. In addition to Spring Training games, Pirate City plays host to events and camps of all sorts year round. Pirate City has become a model facility for other major league franchises to emulate. Major league franchises from all across Florida have traveled to Bradenton to tour Pirate City, including the Tampa Bay Rays, Minnesota Twins, Detroit Tigers, Houston Astros, Arizona Cardinals, Washington Nationals, and the Philadelphia Phillies, as well as many MLB officials and front-office personnel.

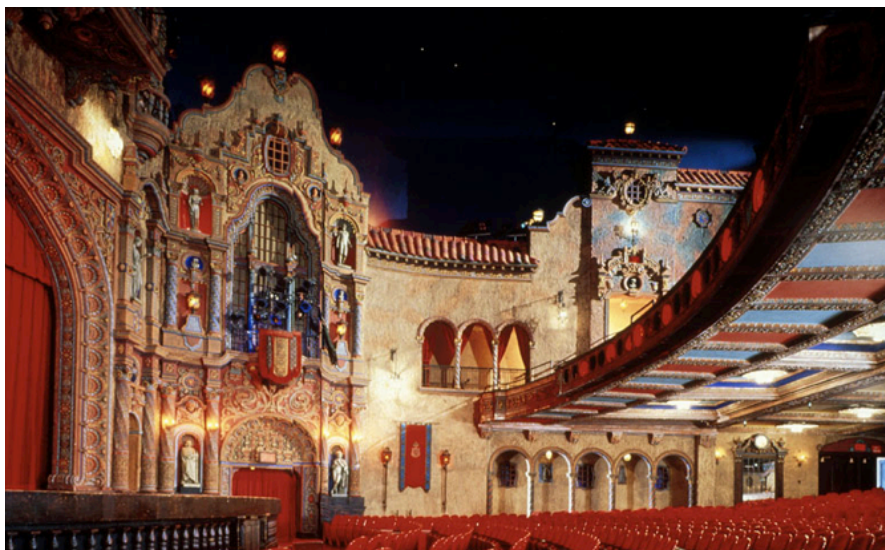

Alan Suskey (President of Suskey Consulting), **Ron Pierce** (President of RSA), and **Natalie King** (Vice President of RSA) will oversee the entire contract which includes the planning phase prior to the legislative session, activities and engagement with key legislative officials during the legislative session, and reporting after the legislative session.

Planning Phase

During the Planning Phase, Alan Suskey, RJ Myers, Ron Pierce and Natalie King will meet with Pinellas County to determine which public policy issues will need to be addressed, create a Pinellas County-specific strategy, address available resources, and create a strategic plan to discuss issues that may arise throughout the course of our team's representation of Pinellas County during each legislative session. In addition, we will begin to coordinate with local lobbyists on issues of collective interest and determine strategies for leveraging these interests during the legislative session.

In Session

During the legislative session in Tallahassee, our team will advocate on behalf of Pinellas County's interests on specific projects or priorities, funding, policy issues as determined

Approach

in the initial planning stage with Pinellas County. A representative from our team will attend all meetings before Tallahassee based officials when relevant business is being conducted.

While in session, RJ Myers and Edward Briggs will send comprehensive and timely reports to Pinellas County staff to keep Pinellas County informed of all key issues that may affect Pinellas County directly or indirectly. RJ and Edward will constantly monitor all bills/amendments to ensure important bills impacting Pinellas County will have a clear strategy in place to either advance or defeat the legislation. A strategy might involve meeting with the bill sponsors, preceding officers staff, and committee chairs to advise them of Pinellas County's position. In some cases, Edward and RJ may testify in committees on behalf of Pinellas County.

In order to ensure all of Pinellas County interests are being represented in Tampa as well as in Tallahassee, our support staff will attend all relevant meetings in the Tampa Bay Area while Alan Suskey, Rob Fields, Ron Pierce, Natalie King, and Edward Briggs are in Tallahassee.

Review

After the legislative session, our team will meet with the Pinellas County Board and key staff (in-person or by phone) to discuss how effectively the strategy created during the Planning Phase was executed in the legislative session. The update will include the an overall budget review and a thorough review of important pieces of legislation. Based on feedback from Pinellas County, the strategic plan may be revised in light of new information or objectives achieved during the legislative session.

Tentative Schedule for Year One

Approach

PRIOR TO SESSION

First 30 Days - Once the contract is signed with Pinellas County, our team will schedule one-two meetings with Pinellas County to begin developing the Legislative Strategy for 2018-2019. The legislative strategy will be based on pending legislative actions, trends, and political activities. The strategy will incorporate State Legislative priorities as determined at the initial meeting between Pinellas County and our team. The legislative strategy will specify which meetings will be arranged, activities that will be monitored, and all goals that will be achieved for 2018 - 2019.

SEP - DEC 2018

PSTA Board Update 2018 Session (January- March)

LEGISLATIVE SCHEDULE:

The 2018 Legislative Session began on January 9, 2018 and concluded on March 12, 2018 which included an extended session in-order for the Legislature to finalize the budget. Since then, Governor Scott has signed the state budget into law. The total budget was \$88.7B. In contrary to years prior Governor Scott only vetoed about \$64M in projects. Mostly targeting member specific projects in the budget cycle. The budget will take effect on July 1, 2018.

It is possible that the Legislature will call a special session during the month of April to address gambling policy. A deal could potentially guarantee billions of dollars for the state by updating a gaming compact with the Seminole Tribe of Florida. The deal, first struck in 2010, provides the tribe with exclusivity over most casino-style games in exchange for monthly deposits to the state treasury.

The 2019 Legislative Session will begin on March 5, 2019 and is scheduled to conclude on May 3, 2019. Due to it being an election year, committee weeks are anticipated to begin in January 2019.

PSTA Board Update 2017 Session (January – May)

LEGISLATIVE SCHEDULE:
The 2017 Legislative Session began on March 7th and concluded on May 8, 2017 which included an extended session in-order for the Legislature to finalize the budget. The budget has yet to be delivered to the Governor. Upon receipt, the Governor will have 15 days to act. It is highly anticipated that the Governor will execute his authority to veto significantly. The budget must be enacted by June 30th as the fiscal year begins on July 1, 2017.

It is possible that the Legislature will call a special session during the month of June to address either Legislation to address the constitutional amendment related to Marijuana and/or any significant effects to the budget if the Governor does in fact veto key portions of the budget.
