Per Countywide Rules Section 7.3.8.5, for the proposed Future Land Use map adjustment from Preservation to Residential Low for the parcels referenced above, I have determined that no wetlands are present landward of the seawalls on these properties.

Property surveys and aerial photography were used in making this determination. Additionally, some of these properties have been developed since before the establishment of the Future Land Use Map with some properties dating to the 1920s.

Map Adjustment – Ozona Area, March 5, 2018

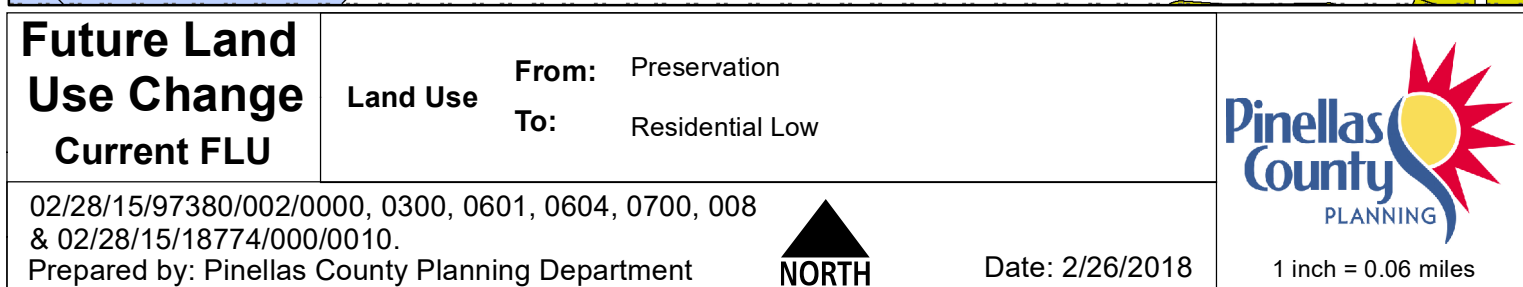
Seven parcels with seawalls or shoreline stabilization: Removal of the Preservation designation on the east (landward) side of these structures and replace with Residential Low designation:

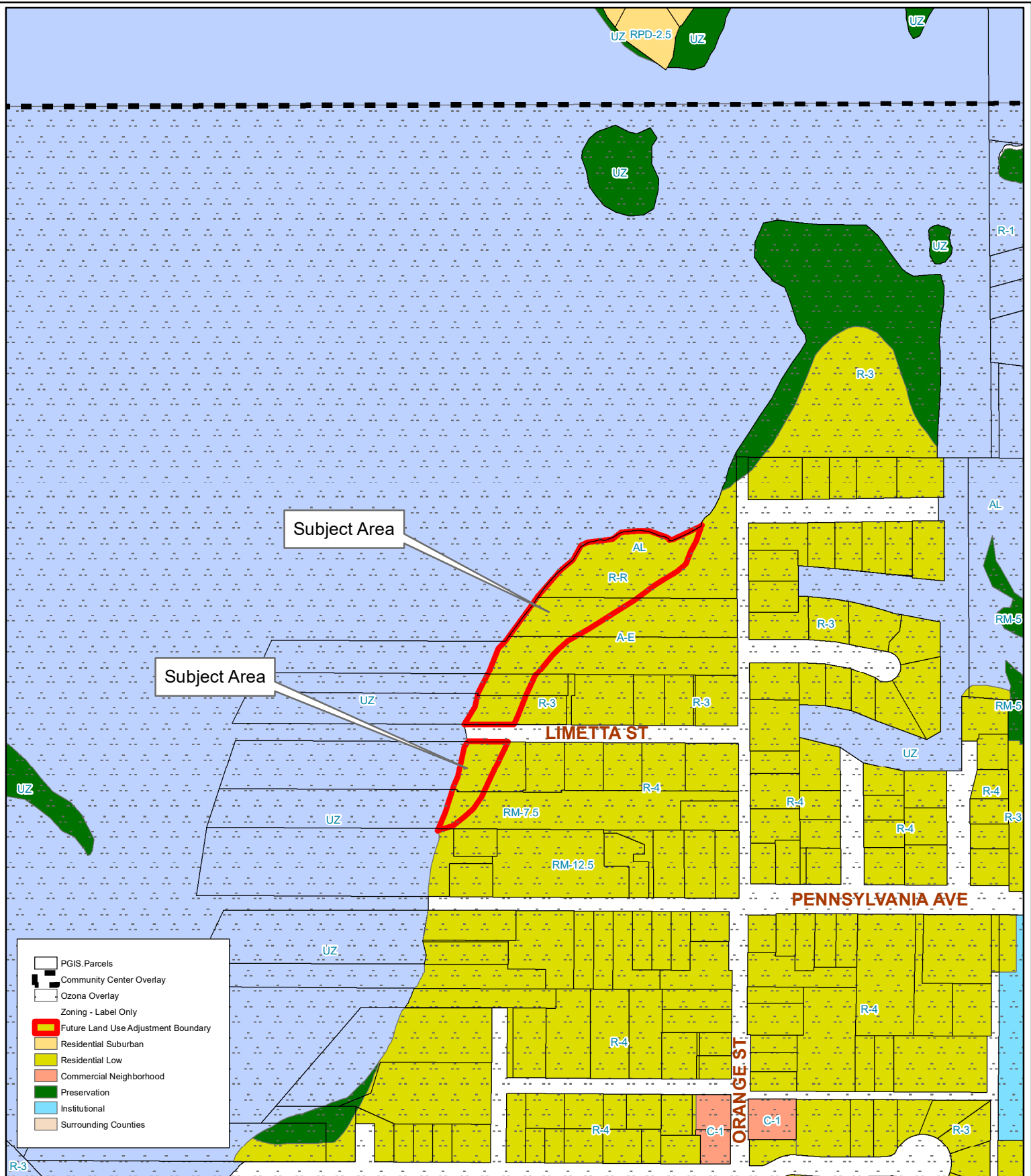
- 605 Orange Street, Parcel ID: 02-28-15-97380-002-0300 – Single-Family Home built in 2003 (replaced a previous home)
- 312 Limetta Street, Parcel ID: 02-28-15-18774-000-0010 – Single-Family Home built in 1973
- 311 Limetta Street, Parcel ID: 02-28-15-97380-002-0601 – Single-Family Home built in 1960
- 325 Limetta Street, Parcel ID: 02-28-15-97380-002-0604 – Single-Family Home built in 1996 (replaced a previous home)
- 629 Orange Street, Parcel ID: 02-28-15-97380-002-0700 – Single-Family Home built in 1925
- 639 Orange Street, Parcel ID: 02-28-15-97380-002-0800 – Single-Family Home built in 1931
- 649 Orange Street, Parcel ID: 02-28-15-97380-002-0000 – Single-Family Home built in 2001 (replaced a previous home)
