FIRST AMENDMENT TO CONCESSION AGREEMENT FOR FOOD AND BEVERAGES

NOW THEREFORE, in consideration of the mutual covenants, agreements and undertakings contained herein, the Parties hereto covenant and agree to amend the Agreement as follows:

ARTICLE 2 / EFFECTIVE DATE AND TERM

Effective on the date of this Amendment:

The Parties elect to extend this Agreement for a month-to-month term, on condition that COUNTY or CONCESSIONAIRE shall notify the other Party not less than sixty (60) days in advance of its desire to terminate this Agreement.
