NINTH AMENDMENT TO GIFT SHOP/NEWSSTAND/RETAIL CONCESSION AGREEMENT

This Ninth Amendment made and entered into this day of 2018, by and between PINELLAS COUNTY, a political subdivision of the State of Florida, hereinafter referred to as LESSOR and STELLAR PARTNERS, INC., hereinafter referred to as LESSEE (individually and collectively hereinafter referred to as Party or Parties).

WHEREAS, LESSOR and LESSEE entered into a GIFT SHOP/NEWSSTAND AND RETAIL CONCESSION AGREEMENT (hereinafter "Agreement") on June 14, 2000, pursuant to Pinellas County Contract No. 990-0302-P for an Airport Terminal Building Concession at the St. Pete-Clearwater International Airport (Airport); and

WHEREAS, LESSOR and LESSEE desire to extend the original term of the Agreement on a month-to-month basis during the solicitation process of the new Request for Proposals (RFP) of this Concession; and

WHEREAS, the Eighth Amendment the LESSEE has exercised, with LESSOR approval, the five-year renewal option period that will expire on July 31, 2018; and

NOW THEREFORE, in consideration of the mutual covenants, agreements and undertakings contained herein, the Parties hereto covenant and agree to amend the Agreement as follows:

1. SECTION 2 / TERM OF AGREEMENT; OPTION TO RENEW

Effective on the date of this Amendment:

LESSOR and LESSEE elect to extend this Agreement for a month-to-month term, on condition that LESSOR or LESSEE shall notify the other Party not less than sixty (60) days in advance of its desire to terminate this Agreement.
