NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereto agree as follows:


- 1. Paragraph 8. MANAGEMENT PLAN: change review time in Management Plan from every five years to every ten years.

It is understood and agreed by LESSOR and LESSEE that in each and every respect the terms of Lease Number 4228, except as amended, shall remain unchanged and in full force and effect and the same are hereby ratified, approved and confirmed by LESSOR and LESSEE as of the date of this amendment.
