WHEREAS, the COUNTY has requested funding from the DEPARTMENT through the LAP for the County Road 694 (Park Boulevard) Project, from Starkey Road to 66th Street North to construct a five (5) to six (6) foot concrete sidewalk (approximately 6,000 linear feet), driveway modifications, curb ramp upgrades, a new mid-block pedestrian signal and pedestrian signal upgrades at intersecting roadways; and

WHEREAS, the COUNTY will be reimbursed from the DEPARTMENT for expenses incurred during the agreement time period that are directly related to the project; and

WHEREAS, the County Road 694 (Park Boulevard) Project, from Starkey Road to 66th Street North has been awarded funding for construction and construction engineering inspection services; and

WHEREAS, the COUNTY is responsible for construction activities and construction engineering inspection services; and

WHEREAS, it is required that execution of a formal Agreement for the transfer of funds for the above activities be entered into between the DEPARTMENT and the appropriate COUNTY officials.
