# **SUPPLEMENTING FY18 BUDGET**

WHEREAS, Section 129.06(3)(b), F.S., provides that budgeted transfers may be made between funds by Resolution;

WHEREAS, such Resolution may amend the budget to increase budgeted transfers between funds; and

**WHEREAS**, Section 129.06(2)(f), F.S., provides that unless otherwise prohibited by law, if an amendment to a budget is required for a purpose not specifically authorized in paragraphs (a)-(e), the amendment may be authorized by resolution or ordinance of the board of county commissioners adopted following a public hearing; and

**WHEREAS**, the Sewer Interest and Sinking Fund requires increased transfers and has reserves for future years that need to be appropriated.

**WHEREAS**, the Board of County Commissioners did, on September 23, 2018 advertise the date, time, place and purpose of the Public Hearing to amend the FY18 Budget pursuant to Section 129.06(2)(f), F.S., in the Tampa Bay Times, a newspaper of general circulation in the County as provided herein.

**THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pinellas County, Florida, in a public meeting duly assembled this 25th day of September, 2018, appropriation in the Sewer Revenue and Operating Fund is realigned, transfers from the Sewer Revenue and Operating Fund to the Sewer Interest and Sinking Fund are recognized, and reserve for future years is realigned within the Sewer Interest and Sinking Fund as follows:
