- 1. The Agreement is hereby amended to increase the Federal funding by <u>\$5,042,697.47</u> and the State share by <u>\$0.00</u> for the maximum amount payable under the Agreement to <u>\$5,335,244.19</u>.
- 2. The Scope of Work, Attachment A to the Agreement, is hereby modified as set forth in the <u>1st</u> Revised Attachment A to this Modification, a copy of which is attached hereto and incorporated herein by reference.
- 3. All provisions of the Agreement being modified and any attachments thereto in conflict with this Modification shall be and are hereby changed to conform with this Modification, effective as of the date of the last execution of this Modification by both parties.
- 4. All provisions not in conflict with this Modification remain in full force and effect, and are to be performed at the level specified in the Agreement.
