ORDINANCE NO. 18-39

AN ORDINANCE AMENDING THE FUTURE LAND USE MAP OF PINELLAS COUNTY, FLORIDA BY CHANGING THE LAND USE DESIGNATION OF APPROXIMATELY 9.59 ACRES LOCATED AT THE SOUTHEAST CORNER OF BELCHER ROAD AND REPUBLIC DRIVE (ADDRESS 2897 BELCHER ROAD) LOCATED IN SECTION 30, TOWNSHIP 28, RANGE 16 FROM INSTITUTIONAL AND RESIDENTIAL LOW MEDIUM TO INSTITUTIONAL; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the application for an amendment to the Future Land Use Map of Pinellas County, Florida, hereinafter listed, has been presented to the Board of County Commissioners of Pinellas County; and

WHEREAS, notice of public hearings and advertisements have been given as required by Florida Law; and

WHEREAS, the comments and recommendation of the Local Planning Agency have been received and considered; and

WHEREAS, this is a small scale development amendment, as defined by Section 163.3187(1), Florida Statutes.

NOW THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Pinellas County, Florida in regular meeting duly assembled this 23rd of October, 2018 that:

Section 1. The Future Land Use Map of Pinellas County, Florida is amended by redesignating the property described as: Approximately 9.59 acres located at the southeast corner of Belcher Road and Republic Drive (address 2897 Belcher Road). Referenced as Case Z/LU-21-09-18, and owned by Clearwater Community Church, Inc., from Institutional and Residential Low Medium to Institutional. Legal description: CLEARWATER COMMUNITY CHURCH, INC. UNNUMBERED LOT TOGETHER WITH BELLE HAVEN, UNIT B LOT 37 & S ½ OF LOT 38 LESS W 17 FT FOR RD R/W.

Section 2. This amendment shall be transmitted to the Pinellas Planning Council for action to amend the Countywide Future Land Use Plan, from Public/Semi-Public and Residential Low Medium to Public/Semi-Public and to maintain consistency with the said Plan.

Section 3. This Ordinance shall take effect upon:

- a) Receipt of notice from the Secretary of State that the Ordinance has been filed is received; and
- b) Approval by the Countywide Planning Authority of the requisite amendment of the Countywide Future Land Use Plan submitted herein pursuant to Chapter 2012-245, Laws of Florida.
- c) Pursuant to Section 163.3187(5)(c), Florida Statutes, this amendment shall become effective upon 31 days following its adoption. If timely challenged, this amendment shall not become effective until the state land planning agency or the Administration Commission issues a final order determining the adopted small scale amendment is in compliance. No development orders, development permits, or land uses dependent on this Amendment may be issued or commence before the amendment has become effective.


