Offshore Notes:

Two skimmer vessels will operate at predetermined but seperate distances from shore. Each will remove debris from offshore waters. Once nets have filled, the vessel will transit to the offload site where the debris will be transferred to awaiting dumpsters via forklift.

Two seperate 1000 foot sections of boom will be anchored, each day based on the latest data and observations including wind, currents, bloom concentrations and physical observations of debris. Skimmer vessel will run along side of the boom to increase the efficiency of debris removal. Boom may be utilized to create a barrier that can be rapidly deployed to minimalize the impact of a know debris field predicted to impact local waters and coastline.

Out Island Beach Cleaning Notes:

A landing craft style work boat will transport a small ATV with small trailer to the out island. Crews will clean the beach by hand with rakes and shovels. Beach debris will be transported to a container on the the work vessel. Once container has reached capacity on the work vessel, the crew will transport debris to the off loading site and debris will be tranfered to awaiting dumpsters.
