FIRST AMENDMENT TO SPECIFIC PERFORMANCE AGREEMENT WITH WESTCARE GULFCOAST-FLORIDA, INC. (CD17WC)

THIS AMENDMENT (AMENDMENT), made and entered into this 30 day of September, 2018, by and between Pinellas County (COUNTY), a political subdivision of the State of Florida, having its principal office at 315 Court Street, Clearwater, Florida 33756, and WestCare Gulf Coast-Florida, Inc., (AGENCY), a not-for-profit corporation organized under the laws of the State of Florida, having its principal office at 100 Second Avenue South, Suite 901 South, St. Petersburg, Florida 33701:

WITNESSETH:

WHEREAS, COUNTY entered into Specific Performance Agreement CD17WC (AGREEMENT) with AGENCY to provide, through the Pinellas County Planning Department (DEPARTMENT), Ninety Thousand and NO/100 Dollars (\$90,000.00) in Community Development Block Grant (CDBG) funds for elevator repairs, parking lot improvements, and the purchase and installation of client lockers at the Davis Bradley Community Involvement Center at 1735 Dr. Martin Luther King Jr. Street South, St. Petersburg, Florida 33705; and

WHEREAS, the 2017-2018 Action Plan, approved by the Board in Resolution 17-37, identified funding be provided to AGENCY for elevator repairs, parking lot grading, resealing and restriping, and the purchase and installation of client lockers at the Davis Bradley Community Involvement Center (the "PROJECT"); and

WHEREAS, during the bid process, bids for the elevator repair portion of the PROJECT came in much higher than anticipated; and

WHEREAS, the parking lot improvement and locker replacement portions of the PROJECT had to be put on hold; and

WHEREAS, additional CDBG funding, has been identified to complete the PROJECT and the bid process for the remaining portions of the PROJECT have been finalized; and

WHEREAS, additional time is needed to complete the parking improvements and locker replacement; and

WHEREAS, it is necessary to amend Section 4. FUNDING of Agreement CD17WC to increase the funding amount of the PROJECT to include an additional \$95,365.00 (Ninety Five Thousand Three Hundred Sixty Five and NO/100 Dollars); and

WHEREAS, it is necessary to amend (f), (g) and (h) of Section 5. SPECIFIC GRANT INFORMATION of Agreement CD17WC to reflect the correct total funding amount of the PROJECT; and

WHEREAS, the AGREEMENT states that the PROJECT activities shall be completed by the AGREEMENT expiration date of September 30, 2018; and

WHEREAS, the **AGENCY**, will not be able to complete the PROJECT on or before the AGREEMENT expiration date of September 30, 2018; and

WHEREAS, the **AGENCY** has requested, and the **COUNTY** has agreed to extend the AGREEMENT expiration date to December 31, 2018.

NOW, THEREFORE, in consideration of the mutual covenants, agreements, understandings, undertakings, representations and promises, and intending to be legally bound thereby, the parties do hereby covenant and agree that the recitals set forth above are true and accurate and are hereby incorporated in and made a part of this AMENDMENT, and further covenant and agree as follows:

1. That Section 3. Term of Agreement; Effective Date, shall be deleted and replaced with the following:

3. TERM OF AGREEMENT; EFFECTIVE DATE

This AGREEMENT is effective on **October 1, 2017**, and unless terminated pursuant to the terms herein, shall continue in full force and effect until **December 31, 2018**, or until **COUNTY'S** full and complete disbursement of funding to **AGENCY**, whichever comes first. **AGENCY** may use the funds provided herein to cover eligible Project expenses incurred by the **AGENCY** between **October 1, 2017** and **December 31, 2018**.

2. That Section 4. Funding subsection (a), shall be deleted and replaced with the following:

4. FUNDING

a) COUNTY, through DEPARTMENT, shall pay AGENCY a maximum of \$185,365.00 (One Hundred Eighty-Five Thousand Three Hundred Sixty-Five and NO/100 Dollars) in CDBG

funding for the PROJECT described in Section 1 ("Project Description") of this AGREEMENT.

3. That Section 5. Specific Grant Information subsections (f), (g) and (h), shall be deleted and replaced with the following:

 - (D) <u>Property Insurance</u>. AGENCY is required to provide an evidence of property coverage in an amount of \$185,365 or more for the duration of this agreement. Property coverage form is special form including wind perils. Evidence of coverage must name Pinellas County as loss payee.
- 5. Except as modified by this AMENDMENT, the remaining terms and conditions of the AGREEMENT shall remain in full force and effect.
