RESOLUTION NO. 18-101

A RESOLUTION BY THE PINELLAS COUNTY BOARD OF COUNTY COMMISSIONERS, IN THEIR CAPACITY AS THE COUNTYWIDE PLANNING AUTHORITY, ACCEPTING THE AMENDED COUNTYWIDE PLAN MAP AND DIRECTING IT BE FILED WITH THE CLERK OF THE BOARD OF COUNTY COMMISSIONERS AS THE OFFICIAL COUNTYWIDE PLAN MAP.

WHEREAS, the Countywide Plan was duly adopted by Pinellas County Ordinance No. 15-30 on August 4th, 2015, with an effective date of August 7, 2015; and

WHEREAS, the Countywide Plan Map has been amended by ordinances approved by the Countywide Planning Authority through August 7, 2018; and

WHEREAS, Forward Pinellas, in its role as the Pinellas Planning Council, authorized the printing of said map for acceptance and filing consistent with Section 2.2.2 of the Countywide Rules; and

WHEREAS, said Countywide Plan Map has been prepared in accordance with that authorization and is available for acceptance and filing.

WHEREAS, Forward Pinellas has recommended the acceptance and filing of the Countywide Plan Map as amended through August 7, 2018, pursuant to Forward Pinellas Resolution No. 18-5.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, as the Countywide Planning Authority, that:

Section 1. The map entitled "Countywide Plan Map, Pinellas County, Florida," effective August 7, 2015, and amended through August 7, 2018, is accepted as the official Countywide Plan Map.

Section 2. Said Countywide Plan Map includes the following:

- a) A color composite Countywide Plan Map amended through August 7, 2018, referred to as Exhibit A:
- b) A color composite Scenic/Noncommercial Corridor map amended through August 7, 2018, referred to as Exhibit B.

Both of which are stated to be a true and correct copy and shall be filed with the Clerk of the Board of County Commissioners.

Section 3. Said Countywide Plan Map, upon acceptance and filing, is authorized for release to local governments and the public consistent with the Countywide Rules.

Section 4. If a question arises as to a conflict between this map and previous action of the Board of County Commissioners as the Countywide Planning Authority by ordinance in amendment of the Countywide Plan Map, that specific ordinance action of the Board of County Commissioners shall govern in such cases.
