

DEP AGREEMENT NO. AB006
AMENDMENT NO. 3

THIS AGREEMENT as entered into on September 14, 2018, and amended on October 15, 2018 and November 21, 2018, between the STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (hereinafter referred to as the "Department") and the PINELLAS COUNTY BOARD OF COUNTY COMMISSIONERS (hereinafter referred to as the "Grantee") is hereby amended.

WHEREAS, the Governor's Emergency Order allows for cleanup of fish/marine life debris associated with red tide, and the Grantee has requested additional funding for this purpose; and,

WHEREAS, the Department has agreed to provide additional funding for this purpose.

NOW, THEREFORE, the parties hereto agree as follows:

1. Section 5 of the Standard Grant Form is hereby revised to show a total amount of funding of \$7,500,000.
2. Attachment 3, PROJECT TIMELINE is hereby deleted in its entirety and replaced with the following:
