Human Services

23. Subrecipient Funding Agreement with the Pinellas County School Board for the Pinellas School

Violence Prevention program.

Agreement approved providing School Board funding in the amount of \$162,788.40 over two years (25 percent) to match Federal funding in the amount of \$488,365.20 (75 percent) to install technology for expedited notification of local law enforcement and automated lockdown responses in 122 public schools by late 2019.

Planning

24. City of Clearwater's 15-Year review of the Downtown Community Redevelopment Trust Fund.

Planning Department Director Renea Vincent related that the Board approved two updates to the Clearwater Downtown Redevelopment Plan in 2018; that the revised spending plan conforms with County Community Redevelopment Area (CRA) policy guidelines; and that staff recommends approval of the 15-year review report as submitted.

City of Clearwater Assistant City Manager Micah Maxwell referred to a PowerPoint presentation titled *Fifteen Year TIF Report* and provided an update on the redevelopment of Downtown Clearwater, noting that there is a significant amount of work that remains to be completed to revitalize the area. He stated that the partnership between the County and the City is functioning well and should continue without change; whereupon, he provided an update on the Imagine Clearwater initiative and requested that the County's Tax Increment Financing (TIF) contribution continue at the 95 percent level for the next 15 years.

Commissioner Welch referred to a document titled *Table 5: Clearwater CRA Capital Expenditures FY2000-FY2016*, and responding to his queries, Mr. Maxwell provided information pertaining to total County TIF contributions, actual expenditures, and developer incentives; whereupon, he related that the City continues to utilize incentives as part of the CRA program. In response to query by Chair Seel, Mr. Maxwell confirmed that the document was reviewed with County staff.

In response to queries by Commissioner Eggers, Ms. Vincent explained that, in the TIF review, the City is required to use the 95 percent set forth in the ordinance review criteria, although it is not strictly applied; whereupon, Commissioner Eggers indicated that using lower levels might make more sense in the future. Mr. Maxwell related that the majority of downtown property is probably tax producing; that the three largest landowners are the City of Clearwater, the Church of Scientology, and possibly the County; and that he will try to obtain information as to the percentage of the Church's property that is tax producing.

A motion was made by Commissioner Long, seconded by Commissioner Welch, that the item be approved. The motion carried by the following vote:

Commissioner Welch suggested that the County create a Community Redevelopment Area focused on poverty reduction in the Clearwater area, similar to ones in Lealman and South St. Petersburg, noting that Mayor George Cretekos is supportive of the concept; whereupon, he referred to a map delineating a poverty zone, and discussion ensued regarding possible approaches. Chair Seel proposed sending a letter to the Cities of Clearwater, Dunedin, and Largo requesting that they develop and submit proposals to the Board, and discussion ensued with input by Ms. Vincent.

Commissioner Eggers expressed support for discussing the blighted concept behind the CRAs and poverty zones, cautioned that the area in the poverty zone be narrowed to avoid providing additional funds to well-off areas, and expressed his support for the County discussing the proposal with the three cities; whereupon, Commissioner Welch related that since he had not previously seen the poverty zone map and did not realize the area was so large, he has not had conversations with officials in Dunedin or Largo on the matter.

Following further discussion, Commissioner Justice requested that staff provide an updated report showing County contributions with regard to the various TIF Districts.

Responding to query by Commissioner Long, Utilities Director Megan Ross provided an update on the sewer system and utilities projects in St. Pete Beach and indicated that all improvements are scheduled to be completed by the end of 2020 in order to bring the systems up to capacity; whereupon, Commissioner Long requested that staff update Senator Jeff Brandes and relate the extent that the County is cooperating with the City to complete the upgrades.

In response to query by Commissioner Peters, Ms. Ross confirmed that although work in a section of St. Pete Beach has not commenced due to lack of funding, the latest information indicates all of the work will be finished by the end of 2020, at which time the moratorium on additional capacity may be lifted; whereupon, Commissioner Long requested that Mr. Burton coordinate with St. Pete Beach officials, and Ms. Ross agreed to obtain information regarding funding arrangements.

He provided information relating to commercial and residential customers, circumference of meters, monthly water usage, future rate increases, and infrastructure improvements, and Ms. Ross discussed the condition of the collection system and how it is monitored and maintained; whereupon, Mr. Dykstra provided information pertaining to the reclaimed water system.

Chair Seel thanked Mr. Dykstra and Ms. Ross and commended them for their creative, balanced approach, noting that a public hearing regarding the proposed rates will take place at the May 21 meeting.
