## **REASON FOR CHANGE**

Unforeseen conditions encountered during interior demolition requires mitigation to meet current one (1) hour fire rated ceiling building codes. This Change Order No. 2, for a time extension and increase, allows Walbridge Aldinger LLC \$345,297.53 for material and labor costs to meet building codes and an extension of sixty-two (62) consecutive Calendar Days to request additional general conditions, bonds and insurance costs.

The Contractor agrees to conform to all existing contract specifications as well as those specific to this Work.

The Agreement term has been increased by sixty-two (62) consecutive Calendar Days. Therefore, the new Agreement term is three hundred and sixty (360) calendar days, making the project completion date of October 28, 2019.
