**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; AUTHORIZING THE LEASE OF REAL PROPERTY BETWEEN PINELLAS COUNTY AND COMMUNITY LAW PROGRAM, INC., A FLORIDA NON PROFIT CORPORATION, PURSUANT TO SECTION 125.38, FLORIDA STATUTES; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Section 125.38, Florida Statutes provides that a county may lease or convey real or personal property owned by the county to a corporation or other not for profit organization which may be organized for the purposes of promoting community interest and welfare upon application by such a corporation or organization; and

**WHEREAS**, Section 125.38 of the Florida Statutes allows the Board to set a price, whether nominal or otherwise for such lease or conveyance, if the Board determines the property is required for such use and not required for County purposes; and

**WHEREAS**, the County owns and operates a building located at 501 First Avenue North, Saint Petersburg, Florida; and

**WHEREAS**, Community Law Program, Inc., a Florida Non Profit Corporation, has applied to the County for a Lease Agreement for the use of the building to be used solely for office space for the purpose of providing pro-bono legal services as requested by the Pinellas County Court system to better serve public clientele; and

**WHEREAS**, the Board has determined that supporting agencies that provide pro-bono legal services as requested by the Pinellas County Court system to better serve public clientele promotes community interest and welfare; and

**WHEREAS**, the Board is satisfied that the real property referred to in this resolution is not currently needed for other County purposes.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pinellas County, Florida:

SECTION 1. The Chairman of the Board of County Commissioners is authorized to execute the Lease Agreement and Second Amendment thereto, allowing Community Law Program, Inc., to use the space referenced in this resolution for office space in support of providing

pro-bono legal services as requested by the Pinellas County Court system to better serve public clientele. The term of the Lease agreement with Community Law Program, Inc., shall be for a period of one year and subject to additional automatic one-year renewals thereafter unless terminated as provided in the Lease Agreement. The rent shall be \$7.42 per square foot, with an annual increase of 3% per year.

SECTION 2. EFFECTIVE DATE. This Resolution shall become effective upon adoption as provided by law.
