### A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; VACATING AN 8 FOOT PORTION OF A DRAINAGE AND UTILITY EASEMENT LYING IN LOT 70, ROLLING OAKS SUBDIVISION, PLAT BOOK 102, PAGES 57 AND 58, LYING IN SECTION 23-27-15, PINELLAS COUNTY, FLORIDA; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Travis H. Duvall and Christina N. Duvall (the Petitioners) have petitioned this Board of County Commissioners to vacate the following described property:




