WHEREAS, a three foot drainage easement will be retained over the north three feet of the vacated right-of-way referenced in Exhibit "A".

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Pinellas County, Florida that the above described property and plat be vacated, insofar as this Board of County Commissioners has the authority to do so, pursuant to §336.09, Florida Statutes in regard to the property referenced in Exhibit "A" and pursuant to §177.101, Florida Statutes, in regard to the property referenced in Exhibit "B".




