## **Description & Comments**

(What is it, any issues found, is there a financial impact to current/next FY, does this contract vary from previous FY, etc.)

This is a grant agreement with the Florida Department of Transportation (FDOT) for the rehabilitation of the terminal parking apron and conversion of Runway 09/27 to a taxiway at the St. Pete Clearwater Airport. FDOT is awarding 50% of the total project not to exceed \$4.5M. The remaining \$4.5M will come from Airport funds.

Design FDOT FY20 = \$750,000 Design Airport FY20 = \$750,000

Construction FDOT FY21 = \$3,750,000 Construction Airport FY21 = \$3,750,000

A more accurate cost of construction will be determined after the design is finished. If the cost of construction is more than the amount currently included in the project's budget, the overage will need to come from Airport Reserves as FDOT's maximum contribution is \$4.5M. Depending on the exact construction, the Airport may wish to reprioritize other projects in the CIP.

While this project is included in PIE's proposed FY20 CIP budget, the scope of the project changed with the award of this grant. This project was going to include an overlay of two parking positions. Now, the scope includes the conversion of decommissioned Runway 9/27 to a taxiway and expansion of terminal parking apron to provide additional parking of air carrier and cargo aircraft. The project budget will be increased for the Tentative Budget.
