The incubator will be open to target industry businesses across the Tampa Bay region. The economic impact estimates call for the incubator to be serving up to 50 companies by year four of operations.

The County intends to comply with the performance period required by the U.S. Economic Development Administration which is the lead funding agency for this project. The start date is 7/29/2019 and the project must be completed within 51 months of this date.

B. What permits are necessary for the public infrastructure project?

City of St. Petersburg Building Permit, Southwest Florida Water Management District Environmental Resources Permit. The specific design of the proposed structure may require a special exception for parking on the western portion of the Property, and a design variance will be needed for the building placement. The City of St. Petersburg Mayor and staff have indicated support for these requests.

The permits have not been secured. The EDA requires the design to be completed and approved by them prior to construction bids. Design will be completed in 2020, with construction documents approved in early 2021 and permits approved in mid-2021. The EDA requires construction to begin in July 2021.

The Land Uses are Multimodal Corridor and Residential Medium. The western 1/3 of the property is zoned Neighborhood Suburban Multi-Family. The eastern 2/3 is zoned Commercial Corridor Traditional. The City amended the land use/zoning designations specifically for the incubator, so it does conform with these uses.

Provide a detailed description of the public infrastructure improvements.

Tampa Bay Innovation Center Incubator - The project includes the design, construction and equipping of an approximate 45,000-square-foot purpose built, state-of-the-art facility to house the Tampa Bay Innovation Center incubator. The project will benefit multiple business enterprises and the community through the operation of the space as an incubator and technology center. The City of St. Petersburg is donating an approximate 2.5-acre site for this project. The site was appraised in 2018 for \$2,460,000. Pinellas County has been awarded an U.S. Economic Development Administration grant of \$7,463,295 towards the design and construction project. Through a competitive process, Pinellas County has selected the non-profit Tampa Bay Innovation Center (TBIC) as the incubator operator. The TBIC has been providing incubation service in Pinellas County for 16 years. Pinellas County will construct and maintain the incubator facility and provide matching funds for a portion of the project. The incubator is sized to achieve financial self-sustainability within a 3 to 4 year timeframe, consistent with the market analysis and financial projections of the incubator feasibility study. The request from the Job Growth Grant program is to fund a portion of the construction and FF&E. The project has already been reviewed by the Florida State Clearinghouse.

Florida Statue 288.01 requires that if public infrastructure is leased, it must be leased at fair market value.

Pinellas County has engaged a third-party non-profit, the TBIC, to operate the incubator. The TBIC will enter into subleases with the end user incubator clients that will be at market rate.

The public infrastructure project is to design and construct a business incubator facility for Pinellas County and the Tampa Bay Region. Targeted industry job growth is a strategic initiative for Pinellas County as provided for in the Economic Element of its Comprehensive Plan. Goal one of the Economic Element is to facilitate a strong and robust local economy that provides growth opportunities for existing businesses, attracts new high-wage

primary employers and promotes a diverse range of industries through innovative, sustainable methods that, in a responsible manner, enhance the county's vitality and the quality of life for residents and visitors.

Pinellas County has a strong historical and ongoing commitment to entrepreneurship, new business development and fostering and growing companies locally. Constructing a state-of-the-art purpose-built incubator will allow the County to better leverage local and regional entrepreneurship and innovation programs/activities to best support start-ups and small businesses to create high salaried jobs throughout the County and the region. The business incubator will support **targeted industry** clusters of research, innovation and entrepreneurial activity in the **technology, FinTech, life sciences, marine sciences, and/or advanced manufacturing sectors**. These industries are also targeted industries of Enterprise Florida. The incubator shall provide two primary functions: (1) support programs and services such as business mentoring/coaching, education, idea validation, strategy development, marketing assistance, network opportunities, workforce development, access to capital, access to b-schools and interns, and standard office resources; and (2) a dedicated workspace that is a combination of leased spaces and flexible collaborative workspaces. The incubator space will also include conference rooms, reception area and common areas serving the incubator tenants.

Pinellas County has an economy that is greatly influenced by external shocks, in particular, construction and tourism are two base industries that are volatile and low paying. In 2017, Hurricane Irma exposed this influence with significant declines in the size of the labor force and the employed population. Following the Federal Disaster Declaration for Hurricane Irma, Pinellas County applied for and was recently awarded \$7,463,295 grant from the U.S. Economic Development Administration to design and construct this incubator facility. The EDA's Economic Adjustment Assistance seeks to improve the County's economic resilience through the diversification of Pinellas County's industry base. The incubator will focus on growing the target industries of Pinellas County to provide economic diversity and opportunities for higher paying employment.

The location of the incubator is within an area where the unemployment rate and per capita incomes levels are an acute problem. The project location is within Census Tract 121030205.00. This tract has a 10 percent unemployment rate which is 3.4 points above the national rate, and per capita income of \$15,053 or 48.28% of the national per capital income, and a 40% poverty rate. The site is located in a federal Opportunity Zone, a Federal HUB Zone, a Florida Community Redevelopment Area, a Florida Brownfield area, and a Florida Urban Job Tax Credit area.

A Market Feasibility Study conducted for the incubator concluded that there is a market for an incubator in the region and concluded that a mixed-use business incubator facility in the City of St. Petersburg would be feasible. While the City of St. Petersburg is the actual location of the incubator, the economic impact will accrue to Pinellas County and the Tampa Bay region, as the incubator will serve entrepreneurs throughout the counties of the Tampa Bay. The business incubator will support targeted industry clusters of research, innovation and entrepreneurial activity in the technology, life sciences, marine sciences, and/or advanced manufacturing sectors. The estimated economic impacts of the proposed incubator are shown in Table 1. The number of jobs to be created and retained will be approximately 670 positions, and client revenues will be about \$100 million.

The total project budget is \$13,500,000 as detailed below. The U.S. Economic Development Administration (EDA) has already made an award of \$7,463,295 for this project with a performance period of 7/29/2019 to 10/29/2023. The City of St. Petersburg is donating land valued at \$2,460,000 which will be conveyed to the County by 10/29/2019. Pinellas County's Board of County Commissioners has already committed to its contribution. Upon a Notice of Grant Award from the Job Growth Grant Fund, Pinellas County will work as a priority with the State of Florida to finalize and execute a Grant Funding Agreement. An additional \$1,500,000 of funding will be obtained from the private sector and other sources over the next 3 years to purchase Furniture, Fixtures and Equipment and provide additional contingency funds.

Detail of Project Cost

Architectural and Engineering Fees - \$825,000 – The project will be completed using a design/bid/build process. This amount includes all costs associated with the design phase.

Project Inspection Fees - \$50,000 – This includes all costs associated with construction and materials inspection.

Site Work - \$950,000 – This includes all work done to prepare the site for vertical construction, including grubbing, grading, tree removal and replacement, and fill. It also includes construction of the building foundation and drainage structures, parking areas, and installation of landscaping.

Construction - \$11,677,000 – This includes all labor and materials for vertical construction, including the following:

Administrative and Legal Expenses - \$668,000 – This includes all of the overhead costs associated with the construction contractor (\$548,000), payment and performance bonds (\$80,000) and general liability insurance (\$40,000).

General Conditions (labor, safety, security, etc.) -- \$584,000

Concrete -- \$887,000

Metals (structural framing, joists and deck) -- \$1,460,000

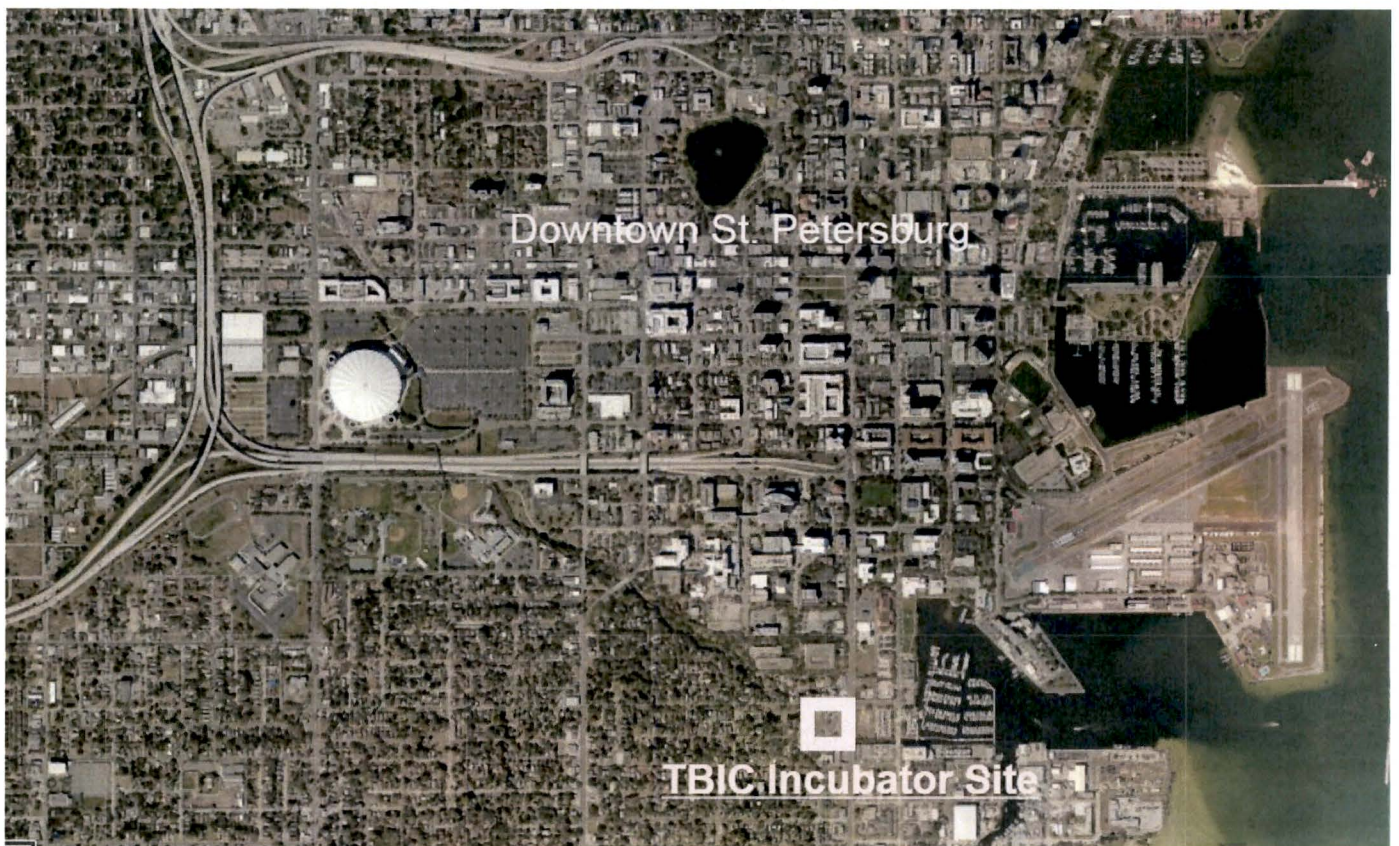
Southeastern Elevation:



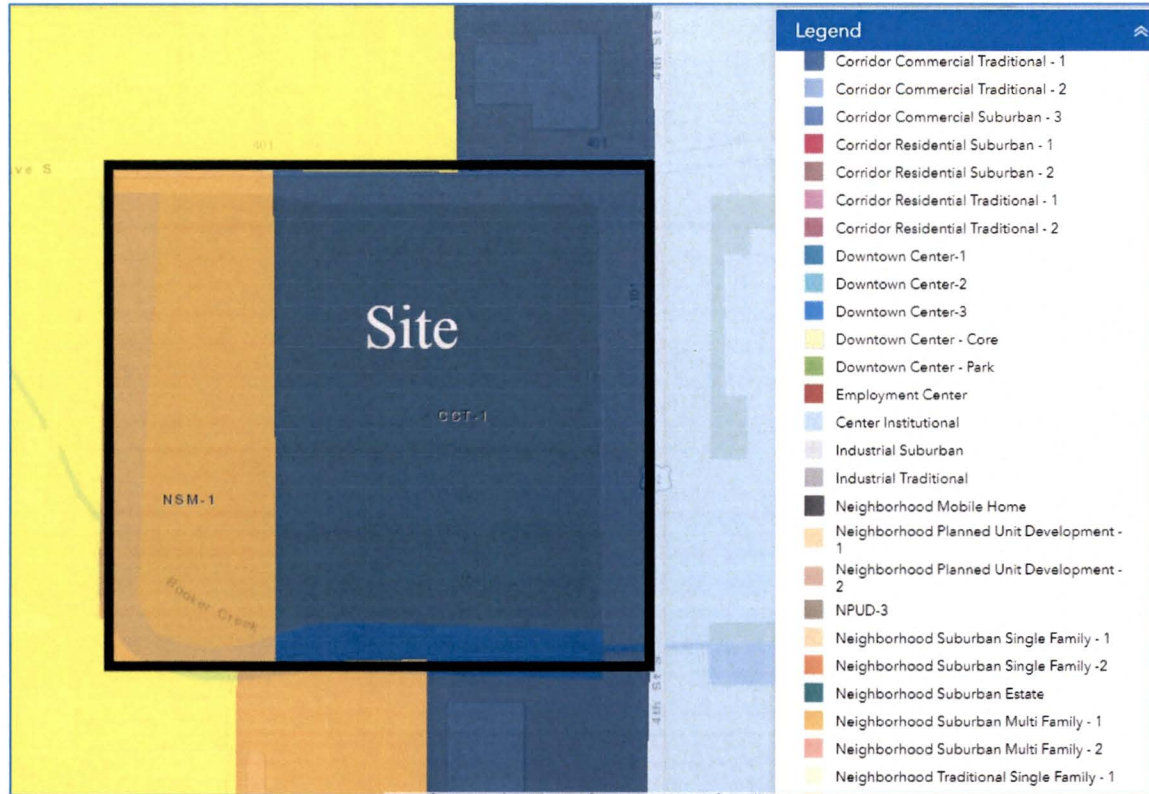

U.S. DEPARTMENT OF COMMERCE INVESTS \$7.5 MILLION TO HELP ESTABLISH THE TAMPA BAY INNOVATION CENTER INCUBATOR

WASHINGTON – Today, U.S. Secretary of Commerce Wilbur Ross announced that the Department's Economic Development Administration (EDA) is awarding a \$7.5 million grant to the Pinellas County Board of Supervisors of Clearwater, Florida, to help build the Tampa Bay Innovation Center Incubator, a 45,000 square foot state-of-the-art business facility. The project, to be located in a [Tax Cuts and Jobs Act](#) designated [Opportunity Zone](#), will be matched with \$4.5 million in local funds, and is expected to create more than 460 jobs and spur more than \$66 million in private investment.

"The Trump Administration is working diligently to support entrepreneurship and innovation across the country, especially by driving business investment to Opportunity Zones through special tax incentives," said Secretary of Commerce Wilbur Ross. "The Tampa Bay Innovation Center Incubator will provide businesses and fledgling entrepreneurs with the technical assistance and space they need to succeed."

"Florida is on a trend of continued economic momentum and the consistent support from the Trump administration is bolstering that trend," said Governor Ron DeSantis. "The Tampa Bay area and our state will significantly benefit from this state-of-the-art business facility, which will help to foster innovation and high-skilled workforce development."

"I proudly supported Opportunity Zones in the Tax Cuts and Jobs Act, and I welcome the Department of Commerce's investment to help build the Tampa Bay Innovation Center Incubator," said Senator Marco Rubio. "The \$7.5 million EDA grant to help build the Tampa Bay Innovation Center Incubator is great news for the Tampa Bay community and Florida's local entrepreneurs. Investments like this build on our state's incredible economic growth and success and give more Florida families the opportunity to succeed."

"There are multiple indicators that our economy is moving in the right direction," said Congressman Gus Biliarkis. "Small business growth is the backbone of our success. This federal investment in Pinellas County will spur private investment in our community and help emerging entrepreneurs create local jobs-a win/win for taxpayers."

The project will be located in the newly created Innovation District on the southern edge of downtown St. Petersburg. This project was made possible by the regional planning efforts led by the Tampa Bay Regional Planning Council. EDA funds the Tampa Bay Regional Planning Council to bring together the public and private sectors to create an economic development roadmap to strengthen the regional economy, support private capital investment, and create jobs.
