3.5.2. Redevelopment Projects

that are developed/redeveloped shall be constructed to comply with the provision of this Manual as new development for that portion of the project where construction is proposed. Any portions of the site Redevelopment projects are required to meet the same flood control and stormwater treatment standards

3.5.1. Exemptions

- -Projects involving construction of less than 3,000 square feet of impervious and semi-impervious vehicular use, is not included in determining the area of impervious and semi-impervious surface. exceeding 3,000 SF. For purposes of this exemption, gravel or shell, un-compacted and not subject to surface. The cumulative construction area and activity will be tracked based on the project or parcel. The applicant will only be allowed to apply this threshold to a cumulative construction area not
- N Single family residences not part of a larger plan of development unless they exceed 10,000 square leet of impervious surface

ISSUES:

4

- 1) Replacement of a mobile home in a mobile home park is not a redevelopment of the **entire** mobile home park as currently interpreted by staff as a "redevelopment project". When replacing a home within a mobile home park the 3,000 square feet exemption should apply to the individual home site, not the entire park.
 - 2) There is tremendous bias and inequity between single-family homes and the treatment of mobile and manufactured homes. This continues with a bias of the storm water assessment fee.
- 3) Manufactured homes are a prime source of affordable housing, and a growing sector of the housing market...should be encouraged per recently discussed by the BOCC.
- 4) This has reached crisis levels in Pinellas County as older, substandard housing cannot be replaced with new affordable manufactured homes.

REQUESTED ACTIONS:

- 1) Immediate suspension/revision of the interpretation and inequity. Revise the exemption & policy for one owner manufactured home parks to be the same as ALL single family lot ownership. Revise the interpretation of "redevelopment project".
 - 1) Work with all stakeholders & industry experts toward rules that work, that are equitable and promote affordable housing.
