Enclosed is our check in the amount of \$1,029,891 which represents excess revenues over expenditures for Fiscal Year 2018-2019.

The amount above includes \$508,490 of unspent capital funds for the Electronic Medication Administration Record system (EMAR). Unexpended grant funds totaled \$521,401. A grant carry-forward of \$448,420 is needed as follows:
