2019 HIGHLIGHTS

Improving Access to Services

Construction is underway on a new service center in St. Petersburg that includes an on-site driver license test course, along with new offices for the Tax Collector and Property Appraiser. The North County Service Center in Palm Harbor is also expanding to add a driving course and a permanent household electronics and chemical collection center.

Addressing Your Needs

- **97%** of Pinellas County app requests acknowledged within one business day
- Nearly **25,000 calls** handled to assist citizens, repair potholes, clear pipes, drains and ditches, and serve other needs
- **90%** average customer satisfaction rate on surveys

Smoother Travel

- **51+** miles of roadway paved
- **108,000+** feet of sidewalk repaired or replaced
- **99%** of reported potholes repaired within 3 days
- **Led 30+** outreach meetings to get citizen input on addressing road congestion, transportation safety and enhanced mobility.

New Liaisons to Serve Our Residents

To better serve the needs of our citizens in unincorporated communities, we designated three liaisons from the County Administrator's Office to embed themselves within the Lealman community, Palm Harbor and North County, and Mid and South County areas.



Making Properties Safer

- **13,356** licensed contractors in the county, up 2% over the prior year
- **4,532** citations issued to licensed and unlicensed contractors, up 279% over the prior year
- **65%** of code issues resolved by voluntary compliance, with an average response time of 1–3 days
- **30,000** permits processed and **90,000** inspections completed to ensure building safety
- **188** site plans reviewed to ensure safe and environmentally friendly development
- **Streamlined** the development review and permitting process based on guidance from citizen-stakeholder committee

Honoring & Serving Local Heroes

- Collaborated with federal, state and local partners to host a Veteran's Resources Expo connecting service members to their earned benefits
- Dedicated a new Purple Heart Memorial at War Veterans' Memorial Park in St. Petersburg

2019 HIGHLIGHTS

Responding to Emergencies

- **91%** of calls answered within 10 seconds
- **640** average EMS calls per day taken by our Regional 911 Center dispatchers through December 2019
- County fall prevention program contributed to **334 fewer** 911 calls for fall-related injuries than previous year



Providing a Helping Hand

- **2,022** claims processed to get local veterans their earned benefits, a 30% increase from the previous year
- **\$1.1 million** in refunds and restitution obtained for residents based on their consumer complaints

- **Age Friendly Pinellas Action Plan** approved by AARP, creating a partnership to fight food insecurity and home solicitation targeting vulnerable seniors

Preparing for the Storm

- **1,000+** people added to the special needs assistance registry, now totaling 6,000

Addressing Behavioral Health & Homelessness

Working with partners, we formed a Collaborative Behavioral Health Team to fill a gap in behavioral health services and continue to reduce homelessness.


Behavioral Health

- **\$11 million** invested to close health system gaps and provide critical services for vulnerable populations
- **\$683,000** invested in comprehensive care program for hundreds of veterans, youth, families and individuals in need of counseling, peer recovery, medication management and psychiatric services

Combating Homelessness

- **174** families transitioned from homelessness to permanent housing
- **259** individuals or families prevented from becoming homeless
- **\$434,000** invested to help people get emergency sheltering and avoid becoming homeless

Protecting Our Environment



Our citizens treasure green space.

2019 HIGHLIGHTS

- **Improved water quality** in almost half of water bodies as a result of county fertilizer ordinance and other environmental measures



- **3,594 acres** of public lakes, ponds and canals maintained to remove invasive vegetation—an area larger than Weedon Island
- **Shell Key Preserve Management Plan** approved to protect shorebirds, sea turtles and other native plants and animals

Accessible Playgrounds

- **2 playgrounds replaced** at Boca Ciega and John Chesnut parks, with new accessible play spaces for children with cognitive, physical and social disabilities




Preventing Floods & Sewer Overflows

- **\$29+ million** in new capital infrastructure projects to reduce sanitary sewer overflows and improve our countywide water distribution system
- **\$19+ million** in infrastructure projects to prevent flooding and protect our environment
- **16,000+ linear feet** of deteriorated drainage pipes replaced to reduce flood risks
- **\$5+ million** saved on flood insurance premiums in unincorporated communities due to maintaining a rating of 5 in the National Flood Insurance Program
- **New Sustainability & Resiliency Coordinator** brought in to build on existing programs for recycling, flood protection, green energy, greenhouse gas inventory and countywide vulnerability assessment

Restoring Our Waterways

The county's second-largest freshwater lake, Lake Seminole, is on track to reach its healthiest state in decades through a major dredging project to **remove 900,000 cubic yards of sediment** that has caused low water quality levels in the lake. This restoration project is slated for completion in 2023 with support from the Penny for Pinellas and state/federal funds.

Eliminating Mosquitoes

- **15% reduction** in mosquitoes that potentially spread disease
- **314,597 acres** treated for mosquitoes—that's 80% of the entire area of the county
- **2,540 service requests** handled to eliminate mosquito breeding issues

Caring for Public Lands

Launched integrated vegetation management planning with city and state partners to identify safest practices for management of invasive plants on public lands

Recycling Leaders

Among top counties in Florida for recycling for the last four years

- **1.7 billion pounds** of trash burned to create renewable energy at the Waste-to-Energy Facility, powering 45,000+ homes per day
- **\$242 million** Waste-to-Energy plant revitalization underway, which will extend the facility's life to at least 2035
- **100% of wastewater biosolids** converted into fertilizer pellets at county treatment facility to reduce environmental impact



Expanding Our Economy

2019 HIGHLIGHTS

Growing Jobs & Higher Wages

- **493,813 people** employed in Pinellas at the end of fiscal year 2019, an all-time high for local employment
- **2,396 jobs** projected to be created or retained due to economic development expansion and relocation support services
- **45,000 square-foot**, state-of-the-art business incubator in the works in south St. Petersburg, designed to support local information technology and advanced manufacturing industry growth. Slated for completion in 2023, this project is funded in part by a \$7.5 million federal grant with land donated by the city.
- **\$154** in direct and indirect wages generated by each \$1 of county incentives
- **\$13.5 million** in projected and completed sales driven by export trade missions

Breaking Tourism Records

- A record **\$62.7 million in bed taxes** collected on overnight stays in fiscal year 2019
- **9th consecutive year** of tourism growth
- **\$56.3 million** in sales tax generated by tourist spending—visitor spending contributes 1/3 of revenue for the county's Penny for Pinellas infrastructure sales tax
- **2.27 million** airport passengers in 2019, marking the 5th consecutive year of record-breaking passenger numbers
- **\$23.8 million in upgrades/renovation** completed at the PIE airport, including new passenger hold room space, restrooms, kids play zone, and enhanced security and customs—all funded by grants and airport revenue



Making Housing Affordable

By pairing local, state and federal dollars with private investment, we're helping more residents find an affordable place to live:

- **130 affordable homes** built/renovated through federal, state and local funds, including the Penny for Pinellas
- **123** down-payment-assistance loans provided to income-eligible homebuyers
- **28 grants awarded** for residents to make critical home improvements
- **55 new homes** built or under construction by Habitat for Humanity in the Ridgecrest and Dansville communities on land purchased by Pinellas County
- **Established guidelines** with city partners for prioritizing investment of Penny for Pinellas funds in land acquisition for affordable housing and capital projects supporting economic development

More Business for Small Business

Small businesses make up 95% of all commercial establishments and employ half our workforce—that's why we've opened the door for more small vendors to compete for local government contracts. This year, the county approved 465 small businesses through the Small Business Enterprise Program, **awarding more than \$7 million in contract payments.** All that money goes right back into our local economy.

Improving our Roads, Bridges & Trails

We partnered with local and state partners to prioritize Complete Streets and other transportation initiatives. These projects are designed to provide safe access for all users, from pedestrians to motorists. We also invested nearly **\$54 million in capital infrastructure projects** to expand and improve roads, bridges, intersections and trails, primarily supported through the Penny for Pinellas. Projects included:

- Pinellas Trail overpass at Alternate 19/Orange Street
- Sidewalk projects along Indian Rocks Road and Haines Bayshore Road
- County Road 1 Advanced Traffic Management System Expansion
- Gulf Boulevard/Belleair Beach Causeway traffic signal mast arm installation

Spurring Redevelopment, Investing in Communities

- Newly-adopted Land Development Code simplified the redevelopment process, with a **48% decrease** in applications going to the Board of Adjustment
- **Linking Lealman** plan rolled out to identify key sidewalk, roadway and other transportation projects that will make travel safer and easier for residents
- **East Lake Community Library addition** completed, funded by Penny for Pinellas
