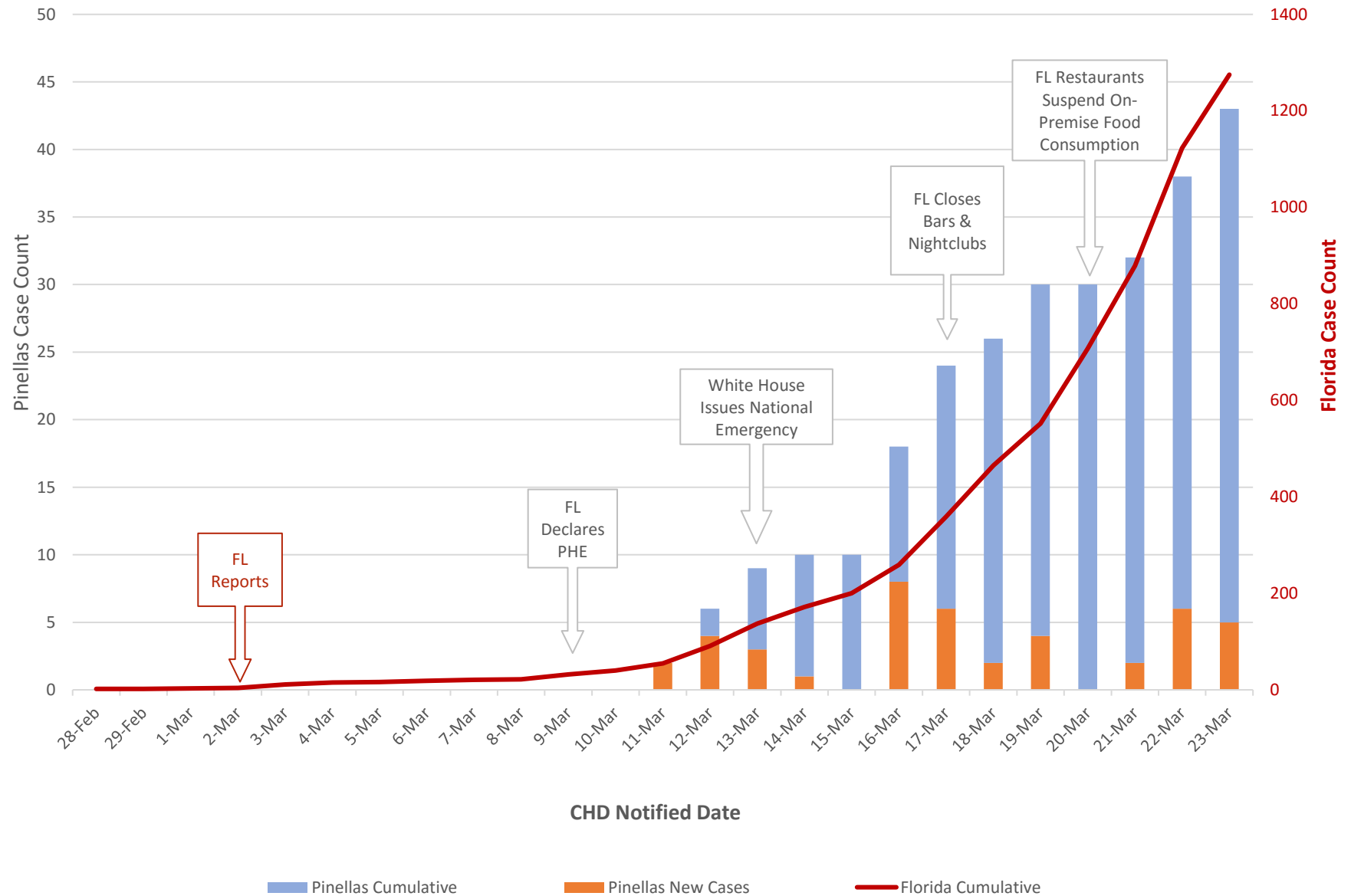
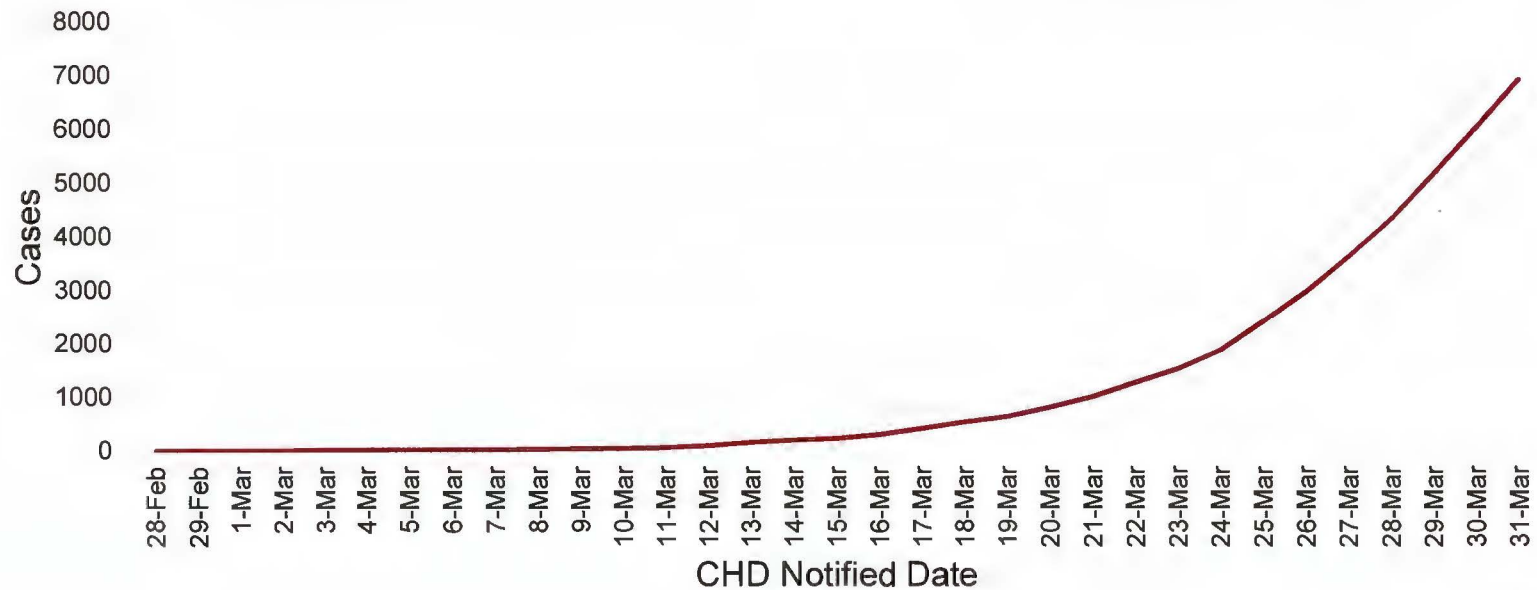


Coronavirus 2019 (COVID19) Cases by CHD Notified Date, Pinellas County vs Florida, 2020

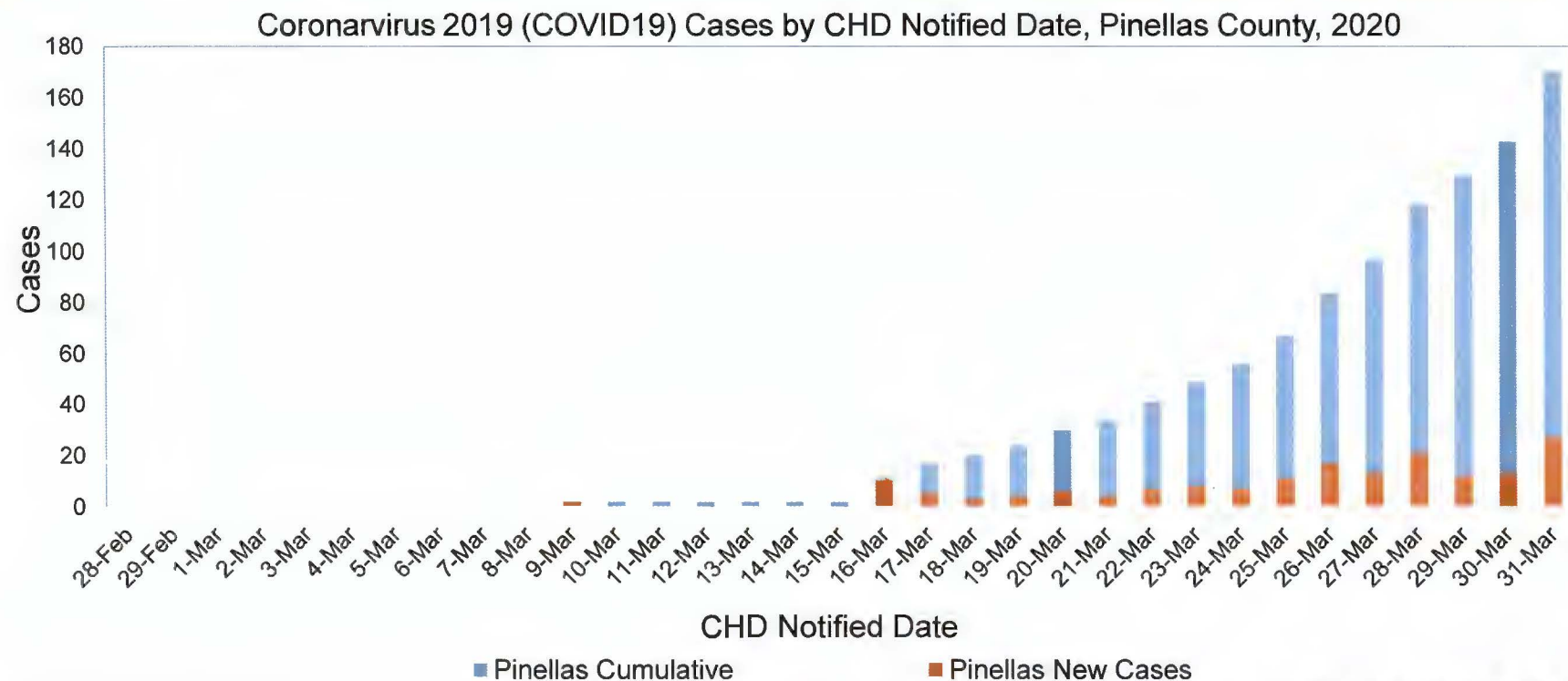


Florida Epi Curve
