According to the U.S Department of Homeland Security's list of essential businesses, under the transportation section, businesses in automotive repair & maintenance are considered essential and therefore can remain operational. The automotive repair & maintenance industry has the NAICS code 8111, of which, Car Washes falls under. Woodie's Wash Shack operates "automotive repair and maintenance" which is recognized by state and federal offices as an "Essential Service." Our business supports community safety, economy, and resilience, at all times and especially during the COVID-19 response. COVID-19 is spread primarily through the touching of commonly used surfaces. With the COVID-19's ability to remain detectable on surfaces like metal & plastic for up to 3 days, Car Washing is arguably more essential than ever before. The process taking place in a Woodie's Wash Shack wash tunnel is a high-pressure chemical washing and rinsing routine that effectively fights against harmful bacteria and viruses like COVID-19. Ultimately, Woodie's Wash Shack assists in helping stop the spread of coronavirus and therefore should be considered an essential business. Car Washes that operate under the "express" model, like Woodie's Wash Shack, are as automated as possible.
