## **REASON FOR CHANGE:**

Contract 167-0513-CP currently has incurred payments and encumbrances of \$5,317,781.00 out of the contract amount of \$7,317,845.00. In preparation for resurfacing projects on Keene Rd, Belcher Rd, and 113<sup>th</sup> St N, we had large diameter stormwater pipes televised to determine pipe conditions and any necessary repairs. Our investigation determined that approximately \$2,100,000.00 in pipe lining is necessary within the project limits of these 3 locations. This expense was not identified during the procurement of this contract. This will reduce our available contract funding to \$77,823.00. Our annual program goal for the Surface Water Assessment lining program is \$2.4 million. To achieve this goal, we are seeking a Change Order to the existing contract in the amount of \$2.1 million so we can proceed with the projects identified above, and to have sufficient funds to meet FY 2020 program goals.

The contractor agrees to conform to all existing contract specifications as well as those specific to this work.

There is no time extension associated with this change order.
