COUNTY ADMINISTRATOR REPORTS

29. County Administrator Reports.

Mr. Burton acknowledged Assistant County Administrator Rahim Harji, noting that he is moving out of state, and thanked him for his dedication and hard work during his tenure with Pinellas County.

Mr. Burton introduced Florida Department of Health in Pinellas County Director Dr. Ulyee Choe, Emergency Medical Services Medical Director Dr. Angus Jameson, and Emergency Management Director Catherine Perkins and provided an update on the Coronavirus Disease (COVID-19); whereupon, he stressed the importance of collaboration between County partners and the need for preparation.

Dr. Choe provided background information pertaining to COVID-19 and statistical information regarding the current number of cases identified. He discussed studies pertaining to antivirals and countermeasures, and related that public health's primary focus is on containment and mitigation.

During discussion and in response to comments and queries by Commissioners Eggers and Welch, Dr. Choe discussed messaging, social distancing, and infographics currently available and in development. He indicated that a local hotline number is available for residents with concerns or symptoms; and that testing is becoming more accessible; whereupon, with input by Mr. Burton, he noted that Pinellas County Schools Superintendent Michael Grego is part of the Executive Policy Group and related that contingency plans for local schools and jails are being addressed.

Responding to query by Chair Gerard, Mr. Burton indicated that Marketing and Communications Director Barbra Hernandez will provide the Board with an itemized list of the key points that Dr. Choe discussed and what measures the County is taking to flatten the curve.

In response to queries by Commissioner Peters, Mr. Burton, with input by Dr. Choe, discussed the efforts being made to convey appropriate messaging to residents and visitors regarding scheduled events and travel in the area; whereupon, Visit St. Pete/Clearwater President and CEO Steve Hayes indicated that current marketing efforts have not changed; and that as the situation progresses, each phase will be addressed with the appropriate reaction.

Ms. Perkins and Dr. Jameson reported that their departments are working with County partners and beyond to communicate information concerning COVID-19 and its impact on Pinellas County, and described measures being taken to keep first responders and health care workers safe through infection control procedures.

In response to query by Commissioner Welch, Dr. Choe clarified that infection control policies are in place for Emergency Room screenings and high-risk testing.
