1. Extension of Contract Duration

Forty-nine (49) calendar days will be added to the contract duration based on good faith efforts by the County to accommodate the Contractor for possible schedule impacts due to hurricane preparation and airport special events. Additional financial compensation will not apply.

The additional forty-nine (49) calendar days, when applied to the Substantial Completion date from Change Order No. 1 of September 11, 2019, would make the new substantial completion date of October 30, 2019.
