### Comments

I support the order to immediately re-open pools and beaches with conditions and humbly ask the Commissioners to consider asking cities with beaches to remove barriers barring beach access points per this order. Understandably, the Board of Commissioners is cautious in this situation, however, we only have roughly 17 new cases per day (since early April) out of 974,996 citizens. That's 0.00175% of our population or 1.75 cases per 100,000 people. We only have 636 total cases (as of April 25 @ 10 AM) with 159 of those from care facilities, which gives us 477 non-facility cases. Remember spread outside of a facility will be more limited due to visitation prohibitions). We also see a declining positivity rate, less than two new cases per day per 100,000 citizens, and ample hospital capacity. Notably, according to the White House Coronavirus Task Force (see April 23 Press Conference) warm temperatures and sunlight reduce the half life of the virus to two minutes instead of 18 hours. Thus, the risk of transmission at a beach or outdoor pool in Florida is minimal. This fact alone strongly supports Pinellas' decision to re-open the beaches. <https://imgur.com/cF6721B> Additionally, I believe the following information also supports the order for Pinellas County to re-open pools and beaches. First, Mayor Curry of Jacksonville discussed on the Florida Task Force Conference Call their working strategy for reopening their beaches (timestamps 3:45-6:40, 20:18-20:40, and 21:45- 22:26. (Listen here <https://thefloridachannel.org/videos/4-22-20-re-open-florida-task-force-industry-working-group-meeting-accommodation-food-tourism-construction-real-estate-recreation-retail-and-transportation/>). He discouraged heavy handed enforcement and noted that beaches had a larger influx of people on the first day; however, media coverage was not accurate (the beaches were not over-crowded) and people thinned out in the days since the re-opening. It is noteworthy that Duval has more cases of COVID-19, but a similar population to Pinellas. Thus, Pinellas is at even lower

risk than Duval in re-opening its beaches. Second, I strongly urge the Commissioners to remember even the good results we have received are showing worse numbers than reality. As noted by the Governor, until now anyone who has tested positive for COVID-19 and then subsequently retested positive for COVID-19 was being reported twice on two separate days, which was inflating positivity percentages. At the bottom of page two on the latest Florida Department of Health report (<https://floridadisaster.org/globalassets/covid19/dailies/covid-19-data---daily-report-2020-04-25-0956.pdf>) you will see that despite the number of positive tests per day being level the percentage of new cases has gone down over the past two weeks in Florida. The same will be true for Pinellas. Third, I am pleased to see the Commissioners recognizing that the Safer-At-Home Orders from both Pinellas and the State were designed to keep us from hitting our hospital capacity. Even at the April 21 Board of Commissioners meeting the medical representative on the call seemed to indicate we have achieved that goal. It was wise for the Commissioners to remember we cannot use "stopping COVID-19" as a justification to continue closures. It rightly acknowledged we cannot stop COVID-19, we can only flatten the curve, which we have done. Fourth, Governor DeSantis indicated on his April 23 press conference Hillsborough County had been successful in its efforts to slow the spread as has Pinellas. Fifth, we have seen many coastal counties (whose statistics closely match our own) open their beaches and loosen restrictions. As the number of counties grows daily the public (as mentioned by the Sheriff) has become discontent with the current lockdown measures put in place by Pinellas. The decision to re-open beaches and keep a close eye on the Governor's direction for businesses is appreciated. Finally, the White House "Best Practices for Every American" says (1) HEAT & HUMIDITY SUPPRESS COVID-19 indoors & outdoor and (2) MOVE ACTIVITIES OUTSIDE sunlight impedes virus transmission. <https://imgur.com/N8tITwc> Again, I support the order to immediately re-open pools and beaches with conditions, I look forward to the Commissioners taking guidance from the Governor concerning re-opening the economy, and humbly request the Commissioners to ask cities with beaches to remove barriers barring beach access points per this order.

To: Pinellas County BCC RE: Immediate Action required at the April 28th BCC meeting to open pools and beaches with restrictions Allow associations to determine restrictions based on social distancing and the size of their pools. If needed the associations can limit entrance to residents only. Prior to the commissioners closing the pools, our association reduced the number of residents at the pools by spacing the chairs 6 feet apart which eliminated chairs thereby limiting the number of residents congregating at the pools. Residents may have moved the chairs, but the number of residents was limited by the number of chairs. If an association is fearful of opening the pools they have the power to keep them closed. The commissioners should never have usurped the associations authority to establish their own social distancing protocol as each community and pool sizes differ. The Sheriff should not be tasked with monitoring social distancing behaviors on private property. The Sheriff should be monitoring speeders as it is more dangerous to drive on the road than swim in a pool or sit on a pool deck. This is not rocket science just common sense which the commissioners should have used before taking away association/resident rights! The BCC also needs to open the beaches at some level, as the Sheriff cannot stop all of the people who are crawling over the no entry signs, yellow tape, rope or plastic fencing. The BCC reacted to fear instead of using common sense when closing the beaches and pools. Making a motion to open the pools and beaches with restrictions should take a minuscule amount of the commissioners' time and every commissioner should vote yes!
