Dear Pinellas County Commissioners, Thank you for your careful protection to date from the spread of COVID 19 in Pinellas County. As we begin PHASE 1 of reopening, we need to remember that we remain in virus time/not human time and that COVID 19 REMAINS A HIGHLY CONTAGIOUS, POTENTIALLY DEADLY VIRUS. Robust testing and contact tracing have yet to be effectively implemented. To allow the floodgates to reopen to beaches in the early part of Phase I could greatly increase the chance that we will have a strong rebound of this disease. To that end, we need to continue close monitoring of the data, (to date there are over 31,000 confirmed coronavirus cases in Florida/1,094 deaths). Of the Florida beaches that have re-opened to date, smart steps have been taken to keep beaches restricted in time and activity (walking, running/not sunbathing). However, it has been observed that few beach goers are wearing protective masks and there are issues with social distancing; it only takes one asymptomatic individual to infect many people. DO NOT OPEN THE PARKING LOTS, RESTROOMS, NOR FULL RE-OPEN OF CLEARWATER BEACH, a beach that has become a strong magnet of crowds, but rather open carefully with restricted hours and

restricted activity; do not yet open the parking lots until we see how this operation works. It is best to do re-opening in small steps that can be measured and observed, rather than leaps and bound. Although spring break has ended, school buildings are closed/(virtual learning has allowed for more flexibility of time) and schools/colleges will soon be completely closed for the summer. As a resident of Clearwater Beach for 15 years, I have seen the local crowds flock here, even when it is not spring break or weekends. With this potential crowd surge, there could more easily be a transmission of this disease for which we have no proven treatment or vaccine. Please also keep in mind that there are over 8,000 residents of Clearwater Beach, with a median age of 63. This

population becomes vulnerable with a crowd surge, as we have seen in other close quarter settings. As far as condo pools are concerned, open the smaller condominium buildings first (16 units or less), again to measure and observe in small steps. Full re-opening of condo pools should not take place until we have a fully effective testing program in place. Even at 50% capacity, which our 156-unit condominium tried before the Safer at Home order was put in place, social distancing was not always practiced, despite guidelines, and no one without Hazmat equipment can practically and continually wipe down all the surfaces touched in this common area environment. Please be cautious, open in carefully measured increments, and keep in mind first the health and welfare of our citizens.
