I am a Hair Salon owner, our salon has been serving this community since 1987. We have 10 hair stylist and 1 barber at our place of business, each stylist & the barber have over 25+ years of experience.

In addition to being licensed, we are all highly trained and exceed our yearly continuing education requirements (CEU's) which primarily focus on cleanliness, sanitation & hygiene. This is a major part of what we do and what we know, we all have many years of individual experience and have worked through the height of the AIDS epidemic.

We all have family's, we are all mothers and most of us are grandmothers, we clearly understand the need for cleanliness, sanitation & hygiene and we would not put our own familys and our customer family at risk. We are properly trained & state licensed professionals that are ready and more than capable to take on the task of of doing our part to get this economy back in motion.

I'm sure you are all aware and know there are other hair stylists out there going door to door or doing hair at their homes, these situations are not only considered unsanitary by the State Board, but are in direct violation of the laws & regulations for state licensed professionals. Each hair salon location is required to be properly licensed and inspected by the state.

As our elected PC Commissioners, please make an effort this weekend to contact & communicate with each other and consider meeting this weekend via Microsoft Teams. Please do your part as soon as possible, to allow us to do our part to keep Pinellas County healthy & safe, and to help get our local economy back on it's feet.

The stress and financial impact we have all been under is enormous. Please take action immediately to allow Hair Salons to open on Monday 5/11/2020 to correspond with the Governor's announcement. Gov. DeSantis announced that salons can open beginning Monday, May 11th...

It seems like a rush to open when we were originally not supposed to reopen until Phase 3 or 4...

Will Pinellas county salons be open as well or are there going to be different re-opening schedule here?

I know for myself and many of my colleagues, we are uncomfortable with the idea of opening up so soon. We CANNOT maintain social distancing while working on a client. And based on the actions I see of the general public as I go to Publix and Target for groceries and household supplies, most ARE NOT following the guidelines put out.

I jam a small business owner in Pinellas county with a boutique cardio kickboxing gym. We have small class sizes of 15 or less and can easily limit it to 10 for phase 1. We don't share any equipment and each person is 6-7 feet from the others. Classes are 50 minutes with 40 minutes between classes to clean and disinfect the gym. We would love to open and follow strict cleaning and class size protocols.

I have tried the governor and Lt. Governor many times and spoken to the Sheriff as well. Please help me get a resolution.

Please call me 917-992-6311 to discuss how to make this happen as soon as possible.

We feel we are different from the big box gyms as they share dumbbells and other exercise equipment.

I hope to hear from you soon.

Although I am not a citizen of Pinellas County, I am a frequent visitor, and a citizen that is very concerned about the future of our State's natural areas, waterways and wildlife.
