THIRD AMENDMENT

This Amendment made and entered into this _____ day of _____, 2020, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Intrado Life & Safety, Inc. hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on January 28, 2014, pursuant to Pinellas County Contract No. 123-0268-P (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Next Generation 9-1-1 networking services for County; and

WHEREAS, Section 5. B. of the Agreement provides for one (1) sixty (60) month term extension upon mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a sixty (60) month term extension, at the same prices, terms, and conditions; and

WHEREAS, Section 19. of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for Change Order No. 5 - Pinellas County Regional 9-1-1 VESTA Refresh.

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. The term of the Agreement shall be extended for a sixty (60) month term extension period, effective from September 1, 2020 through August 31, 2025.
 - 2. The above referenced Change Order is incorporated into the Agreement.
 - Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.

Requirements and Provisions

Pinellas County FL Pinellas County Regional 9-1-1 VESTA Refresh

The following resources, tasks and hours are based on the following assumptions provided by Intrado:

Pinellas County FL is requesting service to support a VESTA refresh. Additionally, Pinellas County is requesting this service be capable of supporting a back up PSAP for Pinellas County the Regional 9-1-1 Primary PSAP, located at the Public Safety Complex (PSC), as a remote off the SPPD VESTA node.

SPPD CPE node addresses are 10750 Ulmerton Rd, Largo FL. (PSC) and 1301 1st Av. N., St. Petersburg, FL SPPD and the ERB site that is being decommissioned in the refresh project is located at 22211 US N Clearwater, FL 33765.

Four (4) new 20 meg circuits will be required to support this project. Two (2) circuits from differing providers will terminate at 10750 Ulmerton Rd, Largo FL and two (2) circuits from differing providers will terminate at 1301 1st Av. N., St. Petersburg, FL.

A total of four (4) new Intrado routers will be deployed to support this project, providing the same level of PSAP ingress network redundancy as the current (single location) configuration.

A total of two (2) new Intrado PSAP Abandonment Devices (PAD) will be deployed to support this project. One (1) PAD devise to abandon/unabandon the Pinellas County the Regional 9-1-1 Primary PSAP and one (1) to abandon/unabandon the new Pinellas County the Regional 9-1-1 Backup PSAP.

No early termination fees will apply for the decommission of the existing circuits to ERB node once that node is relocated and the circuits are decommissioned.

Monthly network charges equaling \$6,400.00 will continued to be invoiced while the ERB site is taken offline.

Early termination fees will apply to the four new circuits in event they are decommissioned earlier than 36 months following activation.
