The law has not changed, only the policy of this supervisor of elections. These public records help provisional ballot voters make sure their vote is counted. We live in the sunshine state. There are strong sunshine laws and public records. This stance by the SOE is non-transparent and anti-voter. Additionally, if you look at the page 5 of the budget request. It lists that this year in 2020, the VBM forecast is supposed to be less than it was in 2019. How is that possible with everything that is going on? How does this SOE expect to promote voting by mail and encourage voting by mail, when they are anticipating a drop in vote-by-mail? This is a failure of transparency and leadership from this office. And this is one of the few times the board has an opportunity to question the practices they approve a budget on. We could also use the CARES act federal money, some of the 24 million dollars, (of which we have 5% of the registered voters in the state, to a tune of 1.2 million dollars of grant money equitably distributed) to expand early voting days and locations. Consider it a federal funded experiment on early voting, to help alleviate the potential risk of voters only showing up on election day.
