Please see the Tampa Bay Time's deadlines for publishing either display ads or legal notices in the classifieds, below. The TBT, as I mentioned during our phone conversation this morning, only publishes legal ads on Wednesday's and Sunday's until further notice.

The Business Observer who we currently publish Petition to Vacate ads with, only publishes on Friday's.

Please see the attached procedures regarding advertising for Petition to Vacates.

If the Petition to Vacate you were calling about this morning fell under F.S. 177.101(4), the ad would have to be published 2x before the hearing (10 days before the hearing and then again, 3 days before the hearing) there still wasn't enough of a lead time to get it to the Business Observer or the TBT in order to meet the statutory requirements for publication. For Petition to Vacates falling under F.S. 336.10, it was definitely pass the deadline to publish the ad (14 days prior to the hearing).

I apologize that I couldn't be of more assistance. Let Jim and I know if you have a future hearing date you would like to advertise the ad. We need the ad draft at least 7 days prior to the publication date.
