A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; VACATING A PORTION OF 118TH AVENUE NORTH (WALSINGHAM ROAD) RIGHT-OF-WAY LYING EAST OF STARKEY ROAD AND WEST OF THE SEABOARD COASTLINE RAILROAD, LYING IN SECTIONS 12-30-15 AND 13-30-15, PINELLAS COUNTY, FLORIDA; RETAINING A UTILITY EASEMENT OVER THE ENTIRE VACATED AREA; PROVIDING FOR AN EFFECTIVE DATE.




