A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; VACATING THE 20 FOOT WIDE ALLEY RIGHT-OF-WAY LYING BETWEEN LOTS 7, 8, 9 AND 10, BLOCK 135, MAP OF SUTHERLAND, PLAT BOOK H1, PAGE 1, LYING IN SECTION 2-28-15, PINELLAS COUNTY, FLORIDA; PROVIDING FOR AN EFFECTIVE DATE.


