Dear Members of the Board of County Commissioners, Reverent greetings to you. My family and I have been Pinellas County residents since 1997, the year we moved here when one of my sons was a toddler and the other an infant. They attended public school, then SPC and FSU. I now also have a 9 year old daughter who last week started attending her new school, a Charter School in our town of Dunedin. I was told that the school is following PCSB guidelines. I am writing to you to express my grave concern for the physical, mental and emotional safety of our children in Pinellas County Schools. I am also concerned about total public health. I have performed much research from reliable sources with no conflicts of interest on such subjects as covid19, lockdown, distancing and masks. I appeal to you today to please remove the guidelines for mask-wearing and distancing in Pinellas County and Pinellas County Schools. Such guidelines are non-evidence-based, unhealthy and unsafe. They have no benefits yet many risks. Natural breathing is critical to immune system function. Viruses are too small to be contained by masks, which only cause children and adults to touch their faces more. Hugs, smiles and facial expressions are critical to overall well-being and connection. In China, there were even deaths of children who were forced to wear masks during PE class. My daughter appears traumatized physically, mentally and emotionally from forced, unconstitutional mask-wearing and anti-social distancing. Instead of fear, education needs to be spread.
