AGREEMENT TO TERMINATE THE INTERLOCAL AGREEMENT FOR TAMPA BAY ADVANCED MANUFACTURING INDUSTRY CERTIFICATION TRAINING CENTERS

This Agreement to terminate the Interlocal Agreement for Tampa Bay Advanced Manufacturing Industry Certification Training Centers (hereinafter "Termination Agreement") is made and entered into by and between Hernando County, a political subdivision of the State of Florida; Pasco County, a political subdivision of the State of Florida; and Pinellas County, a political subdivision of the State of Florida (hereinafter "Counties").

WHEREAS, in July 2014, the Counties entered into an Interlocal Agreement for Tampa Bay Advanced Manufacturing Industry Certification Training Centers (hereinafter "ICTC Interlocal Agreement"), which created the ICTC Governing Board to manage the Tampa Bay Advanced Manufacturing Industry Certification Training Center program, which has since been renamed as the "AmSkills Initiative"; and


WHEREAS, in January 2015, the Counties approved a First Amendment to the ICTC Interlocal Agreement, which amended the duties and responsibilities of the Advisory Boards and the manner in which the members of the Councils are appointed; and

WHEREAS, in July of 2020, the ICTC Governing Board entered into an Agreement of Conveyance, Transfer and Assignment of Assets and Assumption of Obligations with AmSkills, Inc., the not-for-profit corporation created by the ICTC Governing Board to support the AmSkills Initiative, which transferred all of the ICTC Governing Board's assets and obligations to AmSkills, Inc.; and

WHEREAS, because AmSkills, Inc. is now entirely responsible for managing the AmSkills Initiative, and because the ICTC Governing Board no longer has any assets or obligations, there is no longer a need for the ICTC Governing Board to exist, and the Counties wish to terminate the ICTC Interlocal Agreement.

NOW, THEREFORE, Pasco County, Hernando County and Pinellas County agree as follows:

- 1. The ICTC Interlocal Agreement is hereby terminated. This termination shall be effective upon filing pursuant to paragraph 2. below, and shall supersede any conflicting termination requirements in Section 16. of the ICTC Interlocal Agreement. To the extent Section 16. of the ICTC Interlocal Agreement required advanced notice of this termination, the parties hereby waive any requirement of advance notice.
- 2. As required by Section 163.01(11), Florida Statutes, this Termination Agreement shall be filed with the Clerks of the Circuit Courts of Hernando, Pasco and Pinellas Counties, Florida. This Termination Agreement shall take effect upon filing in each county.

AGREEMENT OF CONVEYANCE, TRANSFER AND ASSIGNMENT OF ASSETS AND ASSUMPTION OF OBLIGATIONS

This Agreement of Conveyance, Transfer and Assignment of Assets and Assumption of Obligations ("Transfer and Assumption Agreement") is made effective as of July 24, 2020, by ICTC Governing Board, an entity created by an Interlocal Agreement For Tampa Bay Advanced Manufacturing Industry Training Centers in July, 2014 and governed by such board ("Assignor"), and AmSkills, Inc., a public charity qualified under Section 501(c)(3) of the Internal Revenue Code and as a not-for-profit corporation under Florida law ("Assignee").

WHEREAS, Assignor established Assignee as a separate not-for-profit organization to apply for and receive grant donations and sponsorships to support the AmSkills Initiative, now known as AmSkills, Inc.;

WHEREAS, Assignor has designated Assignee as the official operating public charity to carry out and implement the AmSkills Initiative;

WHEREAS, Assignor seeks to terminate the Interlocal Agreement entered into by and among Pasco, Hernando and Pinellas Counties and transfer all agreements, contracts, assets and liabilities from Assignor to Assignee in order to implement, carry out and expand the AmSkills Initiative:

WHEREAS, Assignor has been engaged in, operated and supported the Am Skills Initiative which was created to engage in and support workforce development, workforce training and apprenticeships (the "Initiative" or "AmSkills Initiative"); and

WHEREAS, Assignor desires to convey, transfer and assign to Assignee, and Assignee desires to acquire from Assignor, all of the assets of Assignor relating to the operation of the Initiative, and in connection therewith, Assignee has agreed to assume all of the liabilities of Assignor relating to the Initiative, on the terms and conditions set forth herein.

NOW THEREFORE, in consideration of the mutual promises and agreements contained herein, the parties hereto, intending to be legally bound hereby, agree as follows:

Section 1. Assignment.

1.1. <u>Assignment of Assets</u>. For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by Assignor, Assignor does hereby assign, grant, bargain, sell, convey, transfer and deliver to Assignee, and its successors and assigns, all of Assignor's right, title and interest in, to and under the assets, properties and Initiative, of every kind and description, wherever located, real, personal or mixed, tangible or intangible, owned, held or used in the conduct of the Initiative (the "<u>Assets</u>"), including, but not limited to, the assets listed on <u>Exhibit A</u> hereto, and identified in part by reference to Assignor's most recent balance sheet (the "<u>Balance Sheet</u>").

1.2 <u>Further Assurances</u>. Assignor shall from time to time after the date hereof at the request of Assignee and without further consideration execute and deliver to Assignee such additional instruments of transfer and assignment, including without limitation any bills of sale, assignments of leases, deeds, and other recordable instruments of assignment, transfer and conveyance, in addition to this Transfer and Assumption Agreement, as Assignee shall reasonably request to evidence more fully the assignment by Assignor to Assignee of the Assets.

Section 2. Assumption of Liabilities.

- 2.1 <u>Assumed Liabilities</u>. As of the date hereof, Assignee hereby assumes and agrees to pay, perform and discharge, fully and completely, (i) all liabilities, commitments, contracts, agreements, obligations or other claims against Assignor, whether known or unknown, asserted or unasserted, accrued or unaccrued, absolute or contingent, liquidated or unliquidated, due or to become due, and whether contractual, statutory, or otherwise associated with the Initiative (the "<u>Liabilities</u>"), including, but not limited to, the Liabilities listed on <u>Exhibit B</u>, and identified in part by reference to the Balance Sheet.
- 2.2 <u>Further Assurances</u>. Assignee shall from time to time after the date hereof at the request of Assignor and without further consideration execute and deliver to Assignor such additional instruments of assumption in addition to this Transfer and Assumption Agreement as Assignor shall reasonably request to evidence more fully the assumption by Assignee of the Liabilities.
- <u>Section 3. Headings</u>. The descriptive headings contained in this Transfer and Assumption Agreement are for convenience of reference only and shall not affect in any way the meaning or interpretation of this Transfer and Assumption Agreement.
- Section 4. Governing Law. This Transfer and Assumption Agreement shall be governed by and construed in accordance with the laws of the State of Florida applicable to contracts made and to be performed entirely within that state, except that any conveyances of leaseholds and real property made herein shall be governed by the laws of the respective jurisdictions in which such property is located.
