I understand that you, the county commissioners, will be voting on whether or not to repeal mask wearing in our county. I ask that you not repeal this ruling. Consider that our positivity rate of 4% only got to that level due to mask wearing, being one of the contributing factors. It is of the utmost importance that you keep in mind the consequences of what WILL happen if mask wearing is repealed; especially at the time when: **bars reopened today and restaurants are up to 50% capacity**. Yes, the economy is slowly opening up. However, keep in mind that things will close down, AGAIN when the virus surges. That's what will happen when more people get sick; along with those individuals who own a business. This will not help the

economy! Who then will run the business and what percent of people will be able to patronize establishments, even if they are open?

I just read this morning that the Dakotas lead the U.S. in virus growth; both rejecting mask wearing. This should be evidence of what occurs when people **do not wear masks**. With doctors (science) predicting that there will be a surge in the virus during fall and winter, now is *not the ideal time* to repeal mask wearing.

**Please** use your better judgment in making your decision. Don't just base your decision on the progress that we have made in getting the positivity rate to under 5%, as proposed by our mayor.
